RESOLUTION

VACATING A PART OF A PUBLIC ROAD WITHOUT PETITION AND FIXING TIME OF VIEW AND FINAL HEARING

Office of the Board of County Commissioners,
Madison County, Ohio

The Board of County Commissioners of Madison County, Ohio, met in regular session on the 30 day of January, 1950, at the office of County Commissioners with the following members present:

Rodney Plymell

Glenn B. Daugherty

George W. Taylor

Mr. Daugherty moved the adoption of the following Resolution:

Whereas, This Board of County Commissioners is of the opinion that it will be for the public convenience or welfare to vacate a part of a Public Road on the line hereinafter described, known as the London-Circleville Road; the same not being a road on the State Highway System.

The following is the general route and termini of said Road:

That portion of former State Route 56 (S. H. 243) Section B (part) and C (part) Madison County between the beginning and end of the new location mentioned below which is not necessary for the construction and maintenance of the proposed improvement. Proposed new location beginning at a point in the center line of the existing State Highway Number 243 S. R. 56) in Pleasant Township, Madison County, said point begin 10,612.8 feet Northerly from the intersection of State Highway No. 243 with the North corporation line of the Village of Mount Sterling, thence Northwesterly for a distance of 4,578.21 feet or 0.867 miles and there terminating. This old right-of-way was abandoned by order of the Director of Highways and is so certified by his letter to the Commissioners of Madison County of December 2, 1948 and entry was made on the Journal of the Director of Highways December 2, 1948.

All of the above mentioned right-of-way is to be vacated with the following exceptions: Beginning at the intersection of the center line of the Dyer Road and the center line of the Old Highway and continuing South 37 deg. 31 min. East for a distance of 482.2 feet, which is to be retained as a County Highway for use as an access road to the property of James Polson.

Resolved, That the 20 day of February, 1950 at 10 O'Clock A. M., be fixed as the date when said Board will view the proposed improvement, on which date we will meet at the residence of William Polson and go over the line of said improvement; and be it further

Resolved, That the 27 day of February, 1950, at 2 O'clock P. M., be fixed as the date for a final hearing thereof, which hearing will be at the office of the Board; and be it further

Resolved, That the Clerk of this Board be and he is hereby directed to give notice of the time and place for both such view and hearing by publication once a week for two consecutive weeks in the Mt. Sterling Tribune a newspaper published and having general circulation in the County, which said notice shall also state briefly the character of said proposed improvement.

Vacating Part of a Public Road (By Publication)

Notice is hereby given that there is before the Board of County Commissioners of Madison County, Ohio, the matter of VACATING A PART OF a Public Road on the line hereinafter described, known as the London-Circleville Road, the general route and termini of which Road are as follows: The portion of former State Route 56 (S. R. 243) Section B. (part) and C (part) Madison County between the beginning and end of the new location mentioned below which is not necessary for the construction and maintenance of the proposed improvement. Proposed new location beginning at a point in the center line of the existing State Highway Number 243 (S. R. 56) in Pleasant Township, Madison County, said point being 10,612.8 feet Northerly from the intersection of State Highway No. 243 with the North corporation line of the Village of Mt. Sterling, thence Northwesterly for a distance of 4578.21 feet or 0.867 miles and there terminating. This old right-of-way was abandoned by order of the Director of Highways and is so certified by his letter to the Commissioners of Madison County of December 2, 1949 and entry was made on the Journal of the Director of Highways December 2, 1949. All of the above mentioned right-of-way is to be vacated with the following exceptions: Beginning at the intersection of the center line of the Dyer Road and the center line of the old Highway and continuing South 37 deg. 31 min. East for a distance of 432.2 feet, which is to be retained as a County Highway for use as an access road to the property of James Polson.

Said Board of County Commissioners has fixed the 20 day of February, 1950 at 10 o'clock A. M., as the date when and Residence of William Polson as the place where said Board will view the proposed improvement, and has also fixed the 27 day of February, 1950, at 2 o'clock P. M., at their office in the Court House of said County, in London, Ohio, as the time and place for the final hearing on said proposed improvement.

D-Resolution to Vacate A Part Of State Route #56

London, Ohio.

February 27, 1950.

Whereas, on January 30, 1950 this Board adopted a resolution to vacate a part of State Route #56 without petition and fixed the date of February 20, 1950 at 10 o'clock A. M. as the time for viewing the proposed project and the 27th day of February, 1950 at 2 o'clock P. M. as the date for the final hearing on the project and a form of notice was prescribed for publication, and,

Whereas, publication of the proposed view and hearing was published in the Mt. Sterling Tribune of Mt. Sterling, Ohio on February 2nd and February 9th, 1950, and,

Whereas, the hearing scheduled for this date was called to order by Chairman, Plymell at 2 P. M. with the Commissioners and the County Engineer present along with one interested person namely William Polson, and,

Whereas, there were no objections to the proposed vacating of a part of State Route #56, therefore, be it,

Resolved, that a part of State Route # 56 be and hereby is determined vacated this 27th day of February, 1950 as described, to-wit:

That portion of former State Route #56 (S. H. 243) Section B. (part) and C (part) Madison County between the beginning and end of the new location mentioned below which is not necessary for the construction and maintenance of the proposed improvement. Proposed new location beginning at a point in the center line of the existing State Highway Number 243 (S. R. 56) in Pleasant Township, Madison County, said point being 10,612.8 feet Northerly from the intersection of State Highway No. 243 with the North corporation line of the Village of Mt. Sterling, thence Northwesterly for a distance of 4578.21 feet or 0.067 miles and there terminating. This old right-of-way was abandoned by order of the Director of Highways and is so certified by his letter to the Commissioners of Madison County of December 2, 1948 and entry was made on the Journal of the Director of Highways December 2, 1948.

All of the above mentioned right-of-ways to be vacated with the following exceptions:

Beginning at the intersection of the center line of the Dyer Road and the center line of the old Highway and continuing South 37 Deg. 31 min. East for a distance of 482.2 feet, which is to be retained as a County Highway for use as an access road to the property of James Polson.
