Beginning at a Black Oak, Bur Oak and Hickory, a Westerly corner to James Johnston's Survey No. 7239; thence with his line N. 23 E. 13 poles to three Bur Oaks; thence S. 87 W. 105 poles to a Bur Oak in a prairie; thence S. 29 W. 52 poles to a Bur Oak; thence N. 79 W. 81 poles to four Bur Oaks; thence N. 69 W. 70 poles to four Bur Oaks, two of them from one root; thence S. 17 W. 50 poles to a Stake in a prairie; thence S. 89 E. 32 poles to a Bur Oak; thence S. 6 E. 54 poles to three Bur Oaks, a Northerly corner to George Galloway's Survey No. 7059; thence with his line S. 20 E. 20 poles to a Bur Oak corner to Galloway's said Survey; thence with another of his lines N. 67 E. 96 poles to four Bur Oaks and a Hickory, another corner to Galloway; thence with another of his lines S. 85 E. 20 poles to a Bur Oak, corner to Galloway's said Survey; thence N. 69 E. 93 poles to two Bur Oaks; thence S. 84 E. 40 poles to two Bur Oaks from one root in the line of Johnston's said Survey; thence with said line North 61 poles to the beginning.
