


Surveyed for Thomas Pemberton 613-1/3 acres of land on part of a Military Warrant No. 2742 on Paint Creek, and the head of Little Miami. Beginning at three Hickories, Northeast corner to George and John Galloway's Survey No. 6615, most easterly corner to John Campbell's Survey No. 9023 in the line of John Shearer's Survey No. 5675; thence with said line North 169 poles to a Stake Northwest corner to said Survey in the line of Stuart and Washington's Survey No. 6063, 6140 and 7184; thence with said line West 51 poles to a Stake Southwest corner to said Survey; thence North 111 poles to a Hickory, Northwest corner to said Survey; thence East 200 poles to a Stake, corner to said Survey in the line of William Washington's Survey No. 6061; thence with his line North 76 poles crossing Paint creek to a White Oak in said line South corner to Henry Brush's Survey No. 7277; thence with Brush's line N. 38 W. 288 poles to a Post Oak corner to said Survey; thence North 24 poles to a Post Oak corner to said Survey; thence West 170 poles crossing the creek to a Hickory, Southwest corner to said Survey; thence South 24 poles to a Stake in the line of Thomas Moore's Survey No. 8226; thence with said line East 56 poles to a Hickory, Black Oak and White Oak, Northeast corner to said Survey; thence South 246 poles crossing a branch to a Stake Southeast corner to said Survey; thence West 144 poles to a Bur Oak, Southwest corner to said Survey, most Northerly corner to Campbell's said Survey, which is the Southerly extremity of Ludlow's line; thence with Campbell's line S. 40 E. 449 poles to the beginning.

Surveyed for Mathew Bonner, assee. 130 acres of land on part of two Military Warrants, 100 acres on No. 6313 and 30 acres on No. 6275 on the waters of Paint creek. Beginning at three Bur Oaks, Southeast corner to the Heirs of Nicholas Hobson's Survey No. 6347, in the line of Creighton and Robinson's Survey No. 6050, 7263 & 7799; thence with Hobson's line West 229 poles to three Bur Oaks, Southwest corner to said Survey in the line of Andrew Dunscomb's Survey No. 3674; thence with said line South 91 poles passing the Southeast corner of said Survey and Northeast corner to Francis Peyton's Survey No. 1244 at 54 poles to a Stake and three Elms, Northwest corner to Daniel Devall's Survey No. 7897; thence with his line East 229 poles to a Stake and four Post Oaks, Northeast corner to said Survey in the line of Creighton and Robinson's said Survey; thence North 91 poles to the beginning.
