Beginning at a spike set on the center-line of Arthur Bradley Road, a distance of 20.12 feet, southwesterly along said center-line from the northeast corner of said 31.094 acre tract.

THENCE, parallel to and 20.00 feet southwesterly from (measured at right angles) said east line of said 31.094 acre tract, S. 37 deg., 21 min., 40 sec. E, a distance of 1834.58 feet to a 3/4" iron rod.

THENCE, at right angles, S 52 deg. 38 min. 20 sec W, a distance of 387.65 feet to a 3/4 iron rod.
