Beginning, for reference, at an iron pin found at the intersection of the centerline of Rosedale-Plain City Road with the centerline of Converse-Huff Road;

thence South 42015'00" West(assumed bearing) 2746.62 feet, following the centerline of Converse-Huff Road, passing at 2433.72 feet the southeast corner of David Perry Yoder's 2.52 acre tract described in deed volume 152, page 478, to an iron pin found at the southeast corner of said 5.91 acre tract and at a southeast corner of said 2.52 acre tract, said iron pin marking the place of beginning;

thence South 42°15'00" West 131.00 feet, continuing with the centerline of Converse-Huff Road and southeasterly line of said 5.91 acre tract, to a railroad spike set;

thence North 47°45'00" West 115.78 feet, crossing said 5.91 acre tract and passing through an iron pin set for reference at 26.00 feet, to an iron pin set in a southerly line of said 2.52 acre tract;

thence North 43°51'00" East 136.66 feet, following a line common to said 2.52 acre tract and said 5.91 acre tract, to a 3 inch angle iron post;

thence South  $44^{\circ}53'00"$  East 112.10 feet, following a line common to said 2.52 acre tract and said 5.91 acre tract and passing an iron pin found at 86.10 feet, to the place of beginning, containing 0.350 acre, more or less, and subject to all valid easements and restrictions of record.

thence South 43°51'00" West 136.66 feet, following a line common to said 2.52 acre tract and said 5.91 acre tract, to an iron pin set;

thence North 47045'00" West 103.22 feet, entering said 2.52 acre tract, to an iron pin set;

thence North 42015'00" East 141.24 feet to an iron

thence South 47°45'00" East 83.25 feet to an iron pin

thence North 43°46'41" East 17.03 feet to an iron pin set:

thence South  $44^{\circ}53'00"$  East 112.10 feet, passing through an iron pin set for reference at 86.00 feet, to a railroad spike set in the centerline of Converse-Huff Road and in the southeasterly line of said 2.52 acre tract;

thence South 42015'00" West 19.00 feet, following the centerline of said Road and southeasterly line of said 2.52 acre tract, to the place of beginning, containing 0.400 acre, more or less, and subject to all valid easements and restrictions of record.
