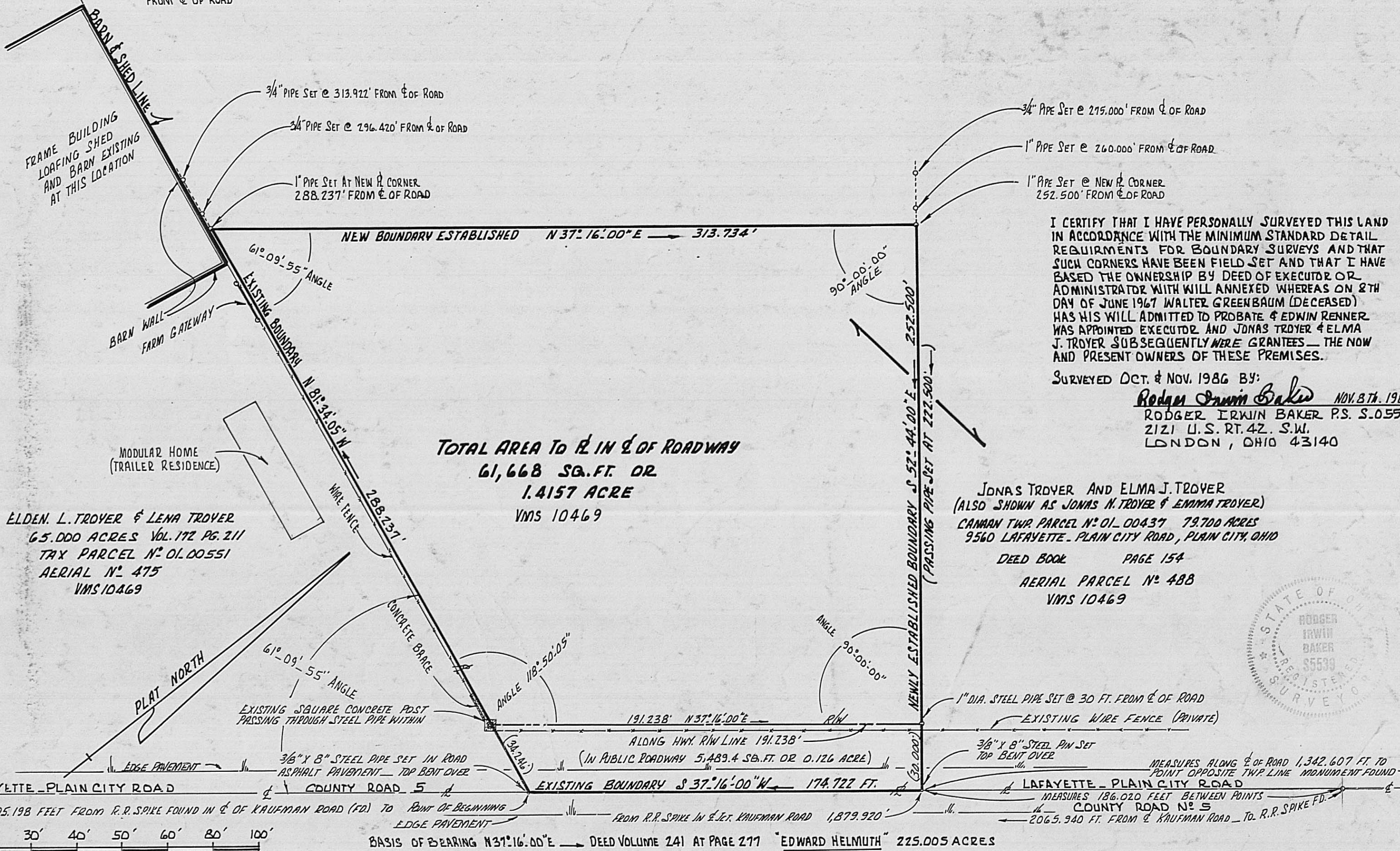


EXISTING CONCRETE POST AT DISTANCE

FROM  $\phi$  OF ROAD



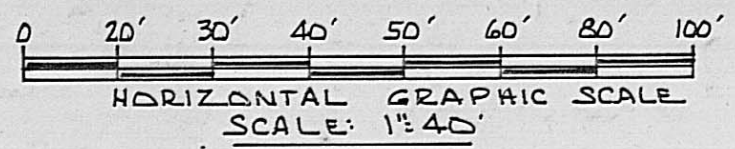
