Thence, with the line between said 220.8964 acre tract and said 172.85 acre tract South 71 deg. 59 min. 23 sec. West 2023.45 feet to an iron pin found;

Thence, continuing with the same line South 23 deg. 10 min. 14 sec. West a distance of 4.89 feet to the true point of beginning

Thence, with the following three new lines across said 172.85 acre tract:

- 1) North 66 deg. 52 min. 47 sec. West a distance of 828.18 feet to an iron pin and cap set;
- 2) South 30 deg. 21 min, 48 sec. West a distance of 741.52 feet to iron pin and cap set;
- 3) South 47 deg. 14 min. 18 sec. West a distance of 2547.22 feet to an iron pin and cap set, in the North line of a 240.51 acretract conveyed to Cloyd Evers, Etal. by Deed Book 220 Page 280;
