

LEGAL DESCRIPTION

0.3934 ACRES

Situated in the State of Ohio, County of Madison, Village of Plain City, VMS 7758-7830, being part of a 2.2943 acre tract in the name of Darby Post 3268, The Veterans of Foreign Wars of the United States, Inc. (hereafter referred to as Plain City VFW), and being more particularly described as follows:

Beginning at a pk nail found in the center of Chillicothe Street, said pk nail being the northeast corner of Plain City VFW's 2.2943 acre tract, thence with center of Chillicothe Street, S 20 deg. 55' 54" E, 100.32 feet to a set pk nail in the center of said road and the southeast corner of Plain City VFW;

Thence along the south boundary of Plain City VFW the following four (4) lines, (1) N 66 deg. 47' 00" W, 45.41 feet to a set iron pipe; (2) N 76 deg. 12' 17" W, 48.82 feet to a set iron pipe; (3) N 66 deg. 43' 17" W, 159.25 feet to a set iron pipe; and (4) N 23 deg. 13' 00" E, 5.00 feet to a set iron pipe.

Thence along a new line through Plain City VFW, N 23 deg. 13' 18" E, 74.80 feet, to a set iron pipe in the north line of Plain city VFW;

Thence with the north line of Plain City VFW, S 66 deg. 47' 00" ~~E 102.77~~ feet to the point of beginning. The herein described parcel contains 0.3934 acres which includes the west one-half of the Chillicothe Street right-of-way. Prepared from a field survey done in March of 1992.

LEGAL DESCRIPTION
0.3602 ACRES

Situated in the State of Ohio, County of Madison, Village of Plain City, VMS 7758-7830, being part of a 2.2943 acre tract in the name of Darby Post 3268, The Veterans of Foreign Wars of the United States, Inc. (hereafter referred to as Plain City VFW), and being more particularly described as follows:

Beginning at a pk nail found in the center of Chillicothe Street, said pk nail being the northeast corner of Plain City VFW's 2.2943 acre tract, thence with Plain City VFW's north line, N 66 deg. 47' 00" W, 102.94 feet to a set iron pipe and the TRUE point of beginning for this description.

Thence along a new line through Plain City VFW, S 23 deg. 13' 18" W, 74.80 feet to a set iron pipe in the south line of Plain City VFW;

Thence with the south line of Plain City VFW, N 66 deg. 43' 17" W, 157.76 feet to an iron pipe set in the east right-of-way line of Bay Street;

Thence with the east right-of-way line of Bay Street, S 3 deg. 10' 39" W, 62.98 feet, to a set iron pipe;

Thence N 77 deg. 44' 18" W, 20.23 feet, to a point in the center of Bay Street;

Thence with the center of Bay Street, N 3 deg. 10' 01" E, 146.82 feet to a point in the center of Bay Street and on the north line of Plain City VFW;

Thence with the north line of Plain City VFW, S 66 deg. 47' 00" E, 204.28 feet (passing a set iron pipe) at 21.29 feet) to the point of beginning. The herein described parcel contains 0.3602 acres which includes the west one-half of the Bay Street right-of-way. Prepared from a field survey done in March of 1992.
