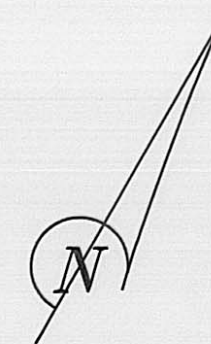

V.M.S. 464 and being part of a 1.356 acre tract (Parcel Five) conveyed to Earl Liff by Deed Book 288 Page 682 and being more particularly described as follows:

Beginning at an iron pin and cap set in the South right-of-way line of East Columbus Ave. (40 foot right-of-way) said iron pin and cap is also at the northern most corner of Parcel four of the subdivision of 2.568 acre tract for Richard B. Powell in 1956 said iron pin and cap is also in the western most corner of said 1.356 acre tract;

Thence, with the South right-of-way of East Columbus Ave. North 45 deg. 00 min. 00 sec. East a distance of 15.98 feet to a State of Ohio right-of-way monument found;

Thence, continuing with the Southern line of said East Columbus Ave. North 45 deg. 41 min. 00 sec. East a distance of 39.02 feet to an iron pin and cap set in said line;

Thence, with a new line across said 1.356 acre tract South 29 deg. 50 min. 13 sec. East a distance of 267.19 feet to an iron pin and cap set in the North line of a 29.496 acre tract conveyed to Clyde R. and Mary Louisa Bandy by Deed Book 158 Page 657;

Thence, with said North line South 67 deg. 45 min. 00 sec. West a distance of 53.67 feet to the Southeast corner of said Parcel 4;

Thence, with the East line of Parcel 4 North 29 deg. 50 min. 13 sec. West a distance of 246.17 feet to the point of beginning containing 0.3136 acres more or less. Bearings are based on the Northwest line of Liff's 1.356 acre tract (North 45 deg. 41 min. East) as described in Deed Book 288 Page 682.

This deed is subject to and with the benefit of all legal highways, restrictions, easements, limitations, and reservations of record, if any, and to zoning restrictions which have been imposed thereon, if any.
