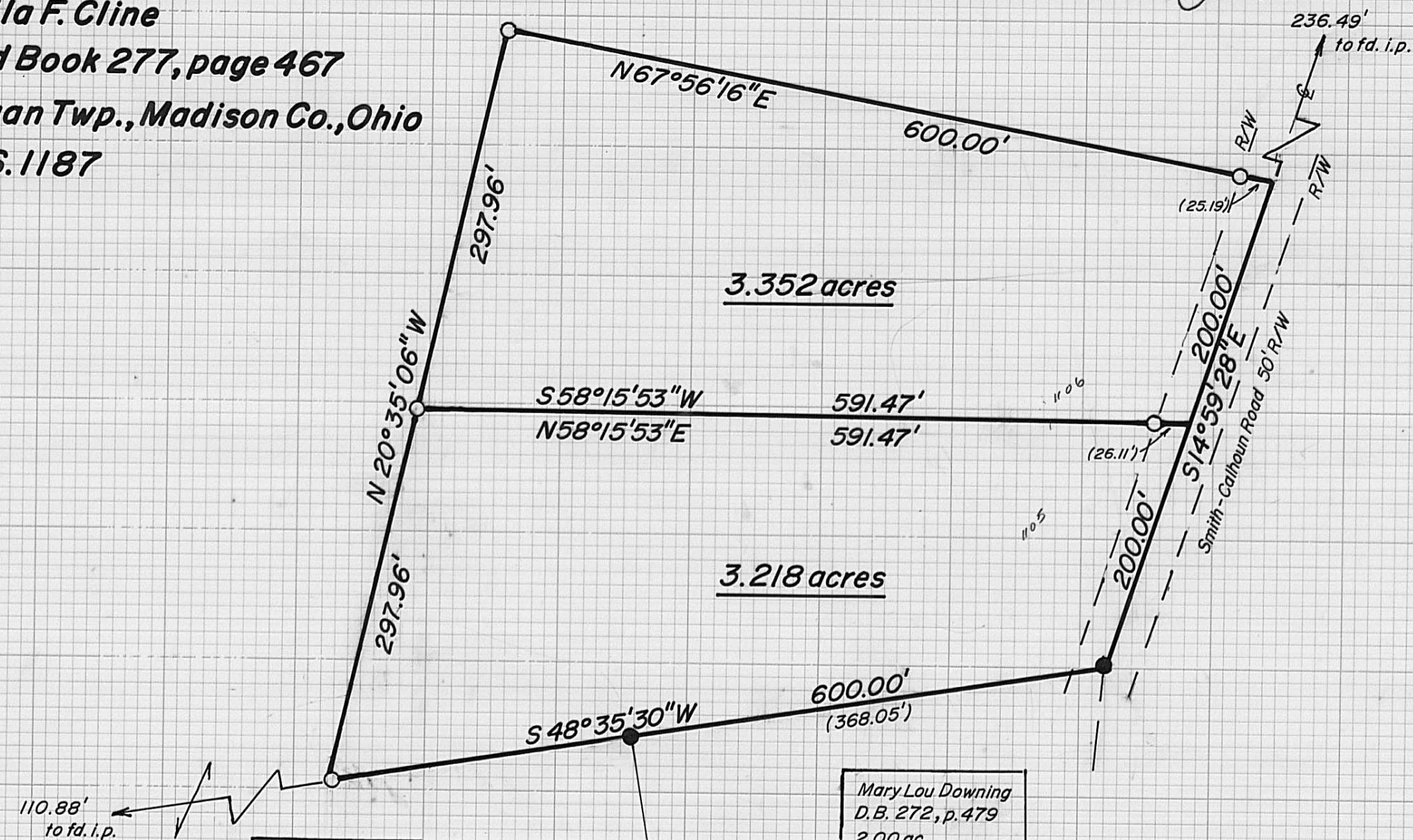

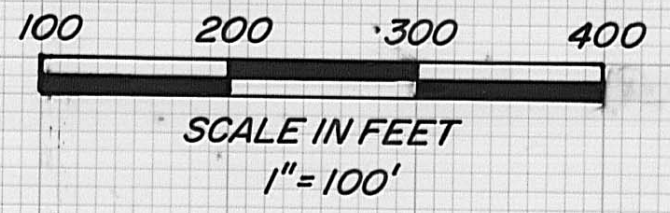

The following description is for a parcel of land, located in the Township of Canaan, in the County of Madison, State of Ohio, V.M.S 1187 and being part of an original 17.61 acre tract recorded in the name of Luella F. Cline in Deed Book 277, page 467, said parcel being more particularly described as follows:

Beginning at a found iron spike in the centerline of Smith-Calhoun Road, said spike being the southeast corner of the abovementioned 17.61 acre tract and the northeast corner of a 2.00 acre tract recorded in the name of Mary Lou Downing in Deed Book 272, page 479;

Thence, with the line between said Downing and Cline, S 48°35'30" W, passing a found iron pipe at 368.05 feet, a total distance of 600.00 feet to a set iron pipe;

Thence, with two new division lines of the abovementioned 17.61 acre tract, N 20°35'06" W 297.96 feet to a set iron pipe;

Thence N 58°15'53" E, passing a set iron pipe at 565.36 feet, a total distance of 591.47 feet to a point on the centerline of Smith-Calhoun Road;

Thence, with said centerline, S 14°59'28" E 200.00 feet to the point of beginning.

The above described parcel contains 3.218 acres. Iron pipes set are 3/4" in width and 30" in length with caps stamped P.S. 7377. Surveyed by William W. Browning in June of 1995.

Thence N 67°56'16" E, passing a set iron pipe at 574.81 feet, a total distance of 600.00 feet to a point on the centerline of Smith-Calhoun Road;

Thence, with said centerline, S 14°59'28" E 200.00 feet to the true point of beginning.
