Being a parcel of land in the State of Ohio, County of Madison, Township of Jefferson, Virginia Military Survey Number 2985, and is part of a 122.906 acre tract recorded in the name of Marvin A. and Betty Lou Yutzy in Deed Book 227, page 415, said parcel being more particularly described as follows:

Beginning at a steel spike found in the centerline of King Pike (40' R/W), said steel spike being the northwesterly corner of the above mentioned 122.906 acre tract and the northeasterly corner of a 71.42 acre tract recorded in the name of Donald E. Forrest in Deed Book 283, page 603;

Thence, with the centerline of King Pike, N. 58° 23' 18" E. 558.66 feet to a set railroad spike;

Thence, with a new division line of the above mentioned 122.906 acre tract, S. 31° 51' 42" E. 2094.54 feet to a set iron pipe in the southerly line of said tract and the northerly line of a 50.00 acre tract recorded in the name of Donald E. Forrest in Volume 006, page 210;

Thence S. 56° 28' 11" W. 628.91 feet to a set iron pipe at the southwesterly corner of the above mentioned 122.906 acre tract and the southeasterly corner of a 71.67 acre tract recorded in the name of Donald E. Forrest in Deed Book 283, page 603;

Thence, with the line between said Forrest and Yutzy, N. 29° 58' 00" W. 2116.45 feet to the point of beginning.

The above described parcel contains 28.680 acres. Iron pipes set are 3/4 in diameter and 30 inches in length with caps stamped P.S. 7377. Thence, with the line between said Forrest and Yutzy, N. 56° 28' 11" E. 1581.59 feet to a set iron pipe at a southeasterly corner of the above mentioned 122.906 acre tract and the northeasterly corner of the above mentioned 50.00 acre tract and in the westerly line of a 50.00 acre tract recorded in the name of Marvin A. and Betty Lou Yutzy in Deed Book 232, page 37;

Thence, with the line between said Forrest and Yutzy, S. 31° 51' 42" E. 790.24 feet to a set iron pipe at the southeasterly corner of the above mentioned Forrest and the northeasterly corner of a 125 acre tract recorded in the name of Dorothy Weson in Deed Book 261, page 596;

Thence, with part of line between said Forrest and Weson, S. 56° 28' 11" W. 1581.59 feet to a set iron pipe;

Thence, with a new division line of Forrest, N. 31° 51' 42" W. 790.24 feet to the point of beginning.
