

## 100.502 Acres

The following description is for a parcel of land in the State of Ohio, County of Madison, Township of Somerford, Virginia Military Survey Number 6014, and is part of a 170.642 acre tract recorded in the name of William and Ann Ward In Deed Book 270, page 770, said parcel being more particularly described as follows:

Beginning at a point on the centerline of State Route 56(60' R/W), said point being the northerly corner of a proposed 9.126 acre tract;

Thence, with two lines of said proposed 9.128 acre tract, S 50°39'23" W, passing a found iron pipe at 36.39 feet, a total distance of 798.21 feet to a found iron pipe;

Thence S 18°08'06" E 520.93 feet to a found iron pipe in the northerly line of a 111.369 acre tract recorded in the name of Lowell and Marcia Meckler in Deed Book 229, page 190;

Thence, with part of the line between the abovementioned Ward and Meckler, S 52\*01'57" W 2173.77 feet to a iron corner post;

Thence N 38\*00'05" W 113109 feet to a set iron pipe at the northwesterly corner of said Ward and the southwesterly corner of a 140.416 acre tract recorded in the name of Franklin E. Deyo in Deed Book 212, page 101;

Thence, with the line between said Deyo and Ward, N 51°22'32" E, passing a concrete corner post at 3121.85 feet a total distance of 3158.57 feet to a point on the centerline of State Route 56:

Thence, with said centerline, S 37\*28'18" E 1038.14 feet to the point of beginning.

The above described parcel contains 100.502 acres. Iron pipes set are 3/4" x 30" with caps stamped P.S.7377. The original plat of this survey, showing additional information, is on permanent file in the Madison County Tax Map Department. Surveyed by William W. Browning, P.S.7377, during January of 1997.

## Drainage Easement

The following description is for a drainage easement in the State of Ohio, County of Madison, Township of Somerford, Virginia Military Survey Number 6014, and is part of a 170.462 acre tract recorded in the name of William and Ann Ward in Deed Book 270, page 770, said easement being 40 feet in width and 20 feet from and parallel with the following described centerline:

Beginning at a point in the in the centerline of State Route 56(60' R/W), said point being a northerly corner of a proposed 9.126 acre tract and a southerly corner of a proposed 100.502 acre tract;

Thence, with said centerline, N 37°28'18" W 529.43 feet to a point, said point being the true point of beginning;

Thence S 55°01'29" W 150.00 feet to a point;

Thence S 10°11'37" E 141.65 feet to apoint;

Thence S 64°28'16" W 347.16 feet to a 15" outlet tile in a concrete headwall.
