Beginning at a point in the centerline of State Route 142 (60 foot right-of-way) said point being at the Northwest corner of said 55.883 acre tract also being the Northeast corner of a 14.012 acre tract conveyed to Jerry M. Alcott by Official Record 26 Page 1009 said point also being corner to the City of London Corporation line;

Thence, with the line between said 55.883 and 14.012 acre tract also the corporation line South 25 deg. 25 min. 14 sec. West passing and 5/8 inch diameter rebar and yellow plastic cap stamped Thomas Engineering and Surveying found at 43.53 feet a total distance of 701.22 feet to an iron pin and cap set at the true point of beginning;

Thence, with a new line across said 55.883 acre tract South 21 deg. 00 min. 00 sec. East a distance of 581.99 feet to an iron pin and cap set in the South line of said 55.883 acre tract also being the North line of Conrail Railroad;

Thence, with said line South 66 deg. 59 min. 44 sec. West a distance of 635.33 feet to a 5/8 inch diameter rebar and yellow plastic cap stamped Thomas Engineering and Surveying found at the Southeast corner of a 10.00 acre tract conveyed to Jerry M. Alcott by Official Record 14 Page 91;

Thence, with the Southeast line of said 10.00 acre tract also the Southeast line of a 14.012 acre tract North 25 deg. 25 min. 14 sec. East, passing a 3/4 inch T bar and cap at 1.19 also passing a 5/8 inch diameter rebar and yellow plastic cap stamped Thomas Engineering and Surveying found at the Southern most corner of said 14.012 acre tract at 14.57 feet, a total distance of 876.49 feet returning to the true point of beginning containing 4.2416 acres more or less.

Beginning at a point in the centerline of State Route 142 said point being the Northeast corner of said 14.012 acre tract also being the northwest corner of a 55.883 acre tract conveyed to MTB Corp. by Deed Book 295 Page 834 said point also being corner to the City of London Corporation line:

Thence, with said corporation line South 25 deg. 25 min. 14 sec. West, passing a 5/8 inch diameter rebar and yellow plastic cap stamped Thomas Engineering and Surveying found at 43.53 feet, a total distance of 701.22 feet to an iron pin and cap set;

Thence, with a new line across said 14.012 acre tract North 21 deg. 00 sec. West, passing an iron pin and set at 433.40 feet, a total distance of 483.40 feet to a point in the centerline of State Route 142;

Thence, with said centerline North 69 deg. 00 min. 00 sec. East, passing a centeline monument assembly found at 479.24 feet, a total distance of 507.98 feet to the point of beginning containing 2.8186 acres more or less.

The here-in-above described 2.8186 acres is to become part of and contingent MTB Corp. 55.883 acre tract as described in Deed Book 295 Page 834.
