beginning at a railroad spike found in the center line of the Plain City-Georgesville Road at the intersection with the southerly line the above mentioned 76.532 acre tract at the northwesterly corner of the Curtis & Charles Crager 72 acre tract, D.B.157, Pg.76, thence from said beginning point North 15 degrees 49 minutes 30 seconds West 497.90 feet, to a nail found at the southwesterly corner of the David and Constance Angel 2.00 acre tract, D.B.255, Pg.335;

thence North 58 degrees 38 minutes 28 seconds East 572.64 feet, with the southerly line of said 2.00 acre tract and a southerly line of the R.L.F. Inc. 15,584 acre tract, D.B.270 Pg.676 to a 3/4 inch pipe found at at an angle in the westerly line of sid tract, and passing a 3/4 inch pipe found at the common corner of said 2.00 & 15.854 acre tract at 340.24 feet;

beginning at a nail found at the northwesterly corner of the West Jefferson Lt'd. 2.368 acre tract, D.B.263, Pg 897, also being the intersection of the center line of the High Free Pike with the Plain City-Georgesville Road thence from said beginning point North 53 degrees 40 minutes East 395.00 feet, along said center and property line, to a railroad spike found at the northeasterly corner of said tract and the northwesterly corner of the R.L.F. Inc. 15.854 acre tract, D.B.270 Pg.676;

thence South 36 degrees 20 minutes East 235.00 feet, with the westerly line of said 15.854 acre tract, to a 3/4 inch pipe found at a common corner of said tracts, also being the easterly corner of the David & Constance
