

The following is a correct boundary description of 9.899.8 square feet of land or 0.22726 acre situated in the City of London, County of Madison, State of Ohio, being a portion of Tract # One of record in D.B. 268 at Pg. 865 in the name of Donald M. Oren, Sr....said tract # one carried as 1.084 acres auditor's parcel number 31-02127.000 located at house # 224 East First Street being bounded and more particularly described as follows:

From a point of reference in the centerline of Maple Street (aka Maple Ave.) on the southerly right of way line projected of East First Street extension and being 25 feet southerly from the middle of First Street and Maple Street intersection...then with the southerly right of way line for East First Street Extension N 67 deg 55 min 00 sec E a distance of 1,063.33 feet to a 4 inch diameter pipe corner post at the true point of beginning and on the westerly line of tract # one of aforesaid Donald M. Oren and on the easterly boundary of Flora B. Tyson 3.89 acres of record in D.B. 159 at Pg. 010;

Thence: With the westerly boundary of Donald M. Oren, Sr. 1.084 acres (tract one) N 22 deg 25 min 00 sec W 25.000 feet to a point in the centerline of East First Street Extension and being the northwesterly corner of said Oren's tract one:

Thence: With the centerline of East First Street extension and the northerly line of Oren's tract one...N 67 deg 55 min 00 sec E 66.000 feet to a point;

Thence: With a division line crossing into tract one...said line surveyed and platted on July 1, 1977...passing a 3/4 inch pipe at 25.00 feet...... S 22 deg 25 min 00 sec E 150.000 feet to a 3/4 inch pipe;

Thence: Crossing through tract one with a surveyed division line of July 1, 1977, S 67 deg 55 min 00 sec W 66.000 feet to a 1/2 inch pipe in an old fence and boundary between said Oren and said Tyson;

Thence: With the common boundary between Oren and Tyson (portions of an old fence) N $22 \ deg \ 25 \ min \ 00 \ sec \ W \ 125.000 \ feet \ to \ the point of beginning.$

Containing within said bounds 9,899.8 square feet of land of which 1,649.97 square feet of land is within the 25 feet right of way width for East First Street extension.

Being a portion of aerial parcel # 622 and being a portion of 1.084 acres carried as Auditor's tax parcel # 31-02127.000...see London Map "C".

Pipes reported were either found or set in year 1977 and described in the description and on the former field survey plat dated July 1 st., 1997. Bearings are based on those perimeter courses of the perimeter of tract one described in D.B. 202 at Pg. 75.

The herein description and the plat from which it is based is a re-tracement of that former landsplit field survey of July 1977.
