N 65°-38'-16" W, a distance of 825.35 feet to a 4 inch metal pipe filled with concrete found.

S 25°-08'-05" W, a distance of 125.38 feet to a 1 inch iron pipe found.

THENCE, with the north line of the Ronald D. Rivers original 288.2432 acre tract, (DB 274, Pg. 926), N 63°-09'-29" W, a distance of 174.32 feet to a 5/8 inch iron rod set.

THENCE, N 24°-33'-35" E, a distance of 1496.04 feet to the true point of beginning, passing a 5/8 inch iron rod set at 1470.21 feet.
