

Description of 3.162 Acre Parcel Surveyed for Fred Parsons

Situate in the State of Ohio, County of Madison, Township of Fairfield, being a part of V.M.S. 5433 and a part of the Parsons' tract of land conveyed to them in O.R. 88, Page 107, Madison County Recorder's Office, being more particularly described as follows:

Commencing at a concrete nail found at the southeast corner the Parsons' tract, the southwest corner of the G.C.& M.R. οf Johnson tract (O.R. 71, Page 719), said nail being in centerline of Big Plain-Circleville Road (50' R/W), (C.R. #4); THENCE, North 75 degrees 45 minutes 49 seconds West, leaving said nail and along Parsons' south line and said centerline for a distance of 141.15' to a P.K. Nail set;

THENCE, North 80 degrees 49 minutes 10 seconds West, continuing along said line and centerline, for a distance of 9.00' to a P.K. Nail set, the POINT OF BEGINNING for the herein described 3.162 acre parcel;

THENCE, North 80 degrees 49 minutes 10 seconds West, along said Parsons' south line and centerline, for a distance of 329.36' to a P.K. Nail set at the Parsons' southwest corner, the southeast corner to J.L.& D. Berry (D.B. 256, Page 760); THENCE, North 06 degrees 28 minutes 06 seconds East, leaving said south line and centerline, along Parsons' westerly line and the Berry's easterly line, and a fence line, passing an iron pipe set at 25.03', for a total distance of 198.98' to a 5/8" iron pipe found at the northeast corner to Berry, the southeast corner to R.K. Gaga (D.B. 293, Page 350), at an angle point in the Parsons'

westerly line; THENCE, North 07 degrees 31 minutes 27 seconds East, continuing along Parsons' westerly line and Gaga's easterly line, and a fence line for a distance of 256.40' to a 5/8" iron pipe found at the northeast corner to Gaga, the northwest corner to Parsons, said pipe being in the south line of the C.D.& R.A. Redding tract (D.B. 168, Page 342), and a fence line;

THENCE, South 77 degrees 43 minutes 43 seconds East, along fence line, the southerly line of Redding, and the northerly line of Parsons', for a distance of 249.03' to an iron pipe set; THENCE, South 09 degrees 05 minutes 38 seconds East, leaving said Redding's south line and Parsons' northerly line, crossing said tract, for a distance of 337.43' to an iron pipe set; Parsons' THENCE, South 08 degrees 50 minutes 41 seconds West, continuing to cross the Parsons' tract, for a distance of 80.00' to an iron pipe set;

THENCE, South 21 degrees 10 minutes 50 seconds West continuing to cross the Parsons' tract, passing an iron pipe set at 16.57 for a total distance of 42.13' to the POINT OF BEGINNING. CONTAINING 3.162 Acres of land, more or less.
