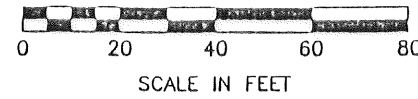
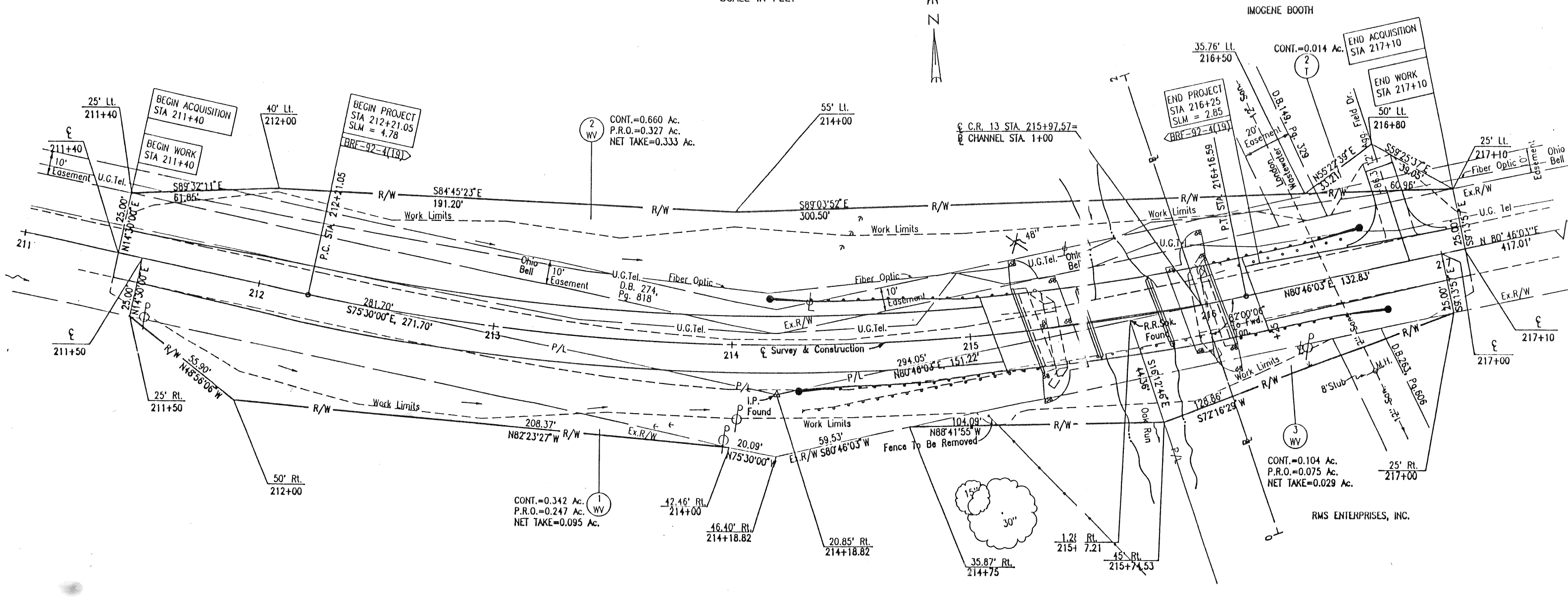

PARCEL NO. 2WV

Being a parcel of land lying on the left and right sides of the centerline of a survey, made for the Department of Transportation, and recorded in Book \_\_\_\_\_, Page \_\_\_\_\_, of the records of Madison County and being located within the following described points in the boundary thereof:

Commencing at a "T" iron found at the intersection of the westerly right-of-way line for Madison Avenue with the centerline of C.R. 13 (Old Springfield Road);

thence South 80° 46'03" West, 417.01 feet along the centerline of C.R. 13 (Old Springfield Road) to a point in the Grantor's southerly property line, being centerline of survey Station 217+10 and also being the place of beginning;

thence South 80° 46'03" West, 294.05 feet along the Grantor's southerly property line to an iron pin found at an angle point, being 20.85 feet right of and radially from Station 214+18.82;

thence North 75° 30'00" West, 281.70 feet along the Grantor's southerly property line to a survey nail (set), being centerline of survey Station 211+40;

thence North 14° 30'00" East, 25.00 feet to an iron pin (set) in the existing northerly right-of-way line for C.R. 13 (Old Springfield Road), being 25.00 feet left of Station 211+40;

thence South 89° 32'11" East, 61.85 feet along the proposed northerly right-of-way line for C.R. 13 (Old Springfield Road) to an angle point and an iron pin (set), being 40.00 feet left of Station 212+00;

thence South 84° 45'23" East, 191.20 feet along the proposed northerly right-of-way line for C.R. 13 (Old Springfield Road) to an angle point and an iron pin (set), being 55.00 feet left of and radially from Station 214+00;

thence South 89° 03'52" East, 300.50 feet along the proposed northerly right-of-way line for C.R. 13 (Old Springfield Road) to an iron pin (set) in the existing northerly right-of-way line for C.R. 13 (Old Springfield Road), being 25.00 feet left of Station 217+10;

thence South 9°13'57" East, 25.00 feet to a survey nail (set), the place of beginning.

Containing 0.660 acres, more or less, of which the present road occupies 0.327 acres, more or less.

Take is 0.535 acres from Auditor's Parcel No. 31-00253 and 0.125 acres from Auditor's Parcel No. 31-00251.

Basis of Bearing: the back tangent for the centerline of C.R. 13 (Old Springfield Road) is South 75° 30'00" East.
