Beginning for reference at a 5/8 inch rebar set with cap at the intersection of the West line of Elm Street (60 feet wide) and the North line of 4th Street (50 feet wide), said point also being the Southeast corner of a tract of land owned by Ronnie Richmond as recorded in Deed Book 292 at Page 71 in the Madison County Records;

Run North 83 degrees 45 minutes 32 seconds West along the North line of 4th Street 127.74 feet to a 5/8 inch rebar set with cap at the East side of a 14 foot alley, said point also being the Southwest corner of the above mentioned Richmond property;

Thence continue North 83 degrees 45 minutes 32 seconds West 7.00 feet to the centerline of said alley for the **True Point of Beginning** of said 0.005 acre tract to be conveyed;

Thence continue North 83 degrees 45 minutes 32 seconds West 4.90 feet to a 5/8 inch rebar with cap;

Thence leaving the North line of 4th Street North 06 degrees 52 minutes 21 seconds East 46.50 feet to a 5/8 inch rebar set with cap;

Thence South 83 degrees 45 minutes 32 seconds East 4.90 feet to the centerline of said alley;

Thence South 06 degrees 52 minutes 21 seconds West along said centerline 46.50 feet to the **Point of Beginning**.

Containing 0.005 acres all in Madison County, Ohio.

Thence South 06 degrees 52 minutes 21 seconds West 19.50 feet to a 5/8 inch rebar with cap;

Thence North 83 degrees 45 minutes 32 seconds West 2.00 feet to the **Point of Beginning**.
