Beginning at an iron pin found at the intersection of the easterly line of State Route 42 and the northerly line of Interstate Route 70 as conveyed to The State of Ohio by D.B. 118, Pg. 13;

Thence along said northerly line \$ 68° 46'48"E a distance of 194.72 feet to an iron pin found at an angle therein;

Thence continuing along said northerly line S 86° 12'20"E a distance of 244.06 feet to an iron pin set at the true place of beginning of the parcel herein described;

Thence N 42° 54'15"E a distance of 348.07 feet to an iron pin set on the southerly line of a 4.367 acre parcel conveyed to Ralph L. Jr. and Terri L. Roberts by O.R. Vol. 107, Pg. 2391;

Thence along the southerly line of lands so conveyed S 47° 35'33"E, a distance of 400.00 feet to an iron pipe found on the northerly line of Interstate Route 70;

Thence along the easterly line of State Route 42 N 38° 20".51"E a distance of 335.83 feet to a 1" pipe found at an angle therein;

Thence continuing along said easterly line N 34° 05'09"E a distance of 151.74 feet to a 1" pipe found at an angle therein;
