

Description of a 2.2022 acre tract Surveyed for Dick Rice

The following described 2.2022 acre tract is situated in the state of Ohio, Madison County, Jefferson Township, VMS 2680, and being part of a 6.2248 acre tract conveyed to Herbert J. and Dorothy A. Rice by Volume 250 Page 257 and being more particularly described as follows:

Beginning at a Harrow Tooth found in the centerline of Morgan Road said Tooth is at the southeast corner of a 0.07 acre tract conveyed to the Leon F. Creamer by official record 81 page 893

Thence, with the northwest line of said 0.07 acre tract, also the northwest line of a 0.9312 acre tract conveyed to Leon F. Creamer by official record 81 page 893, North 35 deg. 12 min. 32 sec. West, passing an iron pin and cap set at 20.00 feet, a total distance of 218.00 feet to the northernmost corner of said 0.9312 acre tract also being the true point of beginning

Thence, with the north west line of said 0.9312 acre tract, South 55 deg. 00 min. 00 sec. West a distance of 199.78 feet to an iron pin and cap set in the east line of a 5.132 acre tract conveyed to Paul R. and Cathy Stephenson by Volume 297 p. 465

Thence, with said east line North 35 deg. 12 min. 32 sec. West a distance of 479.69 feet to a 3 inch metal fence post found in the south line of a 177.489 acre tract conveyed to Robert(Jr.) and Adeline Wilson by Volume 200 page 86, said metal fence post also being the line between VMS 6643 and 2680

Thence, with said line North 54 deg. 43 min. 26 sec. East a distance of 199.78 feet to an iron pin and cap set

Thence, across said 6.2248 acre tract, South 35 deg. 12 min. 32 sec. East a distance of 480.65 feet returning to the true point beginning containing 2.2022 acres more or less.

The here and above described 2.2022 acre tract is to become part of and contingent to Creamer's 0.9312 acre tract

The following described 20 ft. drainage easements are situated in the state of Ohio, Madison County, Jefferson Township, VMS 2680, and extends across a 6.2248 acre tract conveyed to Herbert J. and Dorothy A. Rice by Volume 250 Page 257 also across a 0.9312 acre tract conveyed to Leon F. Creamer by official record 81 page 893 and being more particularly described as follows:

First 20 foot drainage easement:

Said 20 foot drainage easement is tangent to and 10 feet left and right of the following described centerline:

Beginning at a mag nail set in the centerline of Morgan Road (40 foot right-of-way) (County Road 46) said mag nail being at the southwest corner of a 5.1475 acre tract conveyed to John R. and Cinnamon Swaney by official record 107 Page 1638, said mag nail also being corner to said 6.2248 acre tract

Thence, with the southwest line of said 5.1475 acre tract, North 35 deg. 19 min. 05 sec. West, passing an iron pin cap previously set at 20.00 feet, a total distance of 370.26 feet to the true point beginning of the centerline of said 20 foot drainage easement

Thence, North 86 deg. 16 min. 35 sec. West a distance of 401.49 feet to a point in the centerline of a swale and the western terminus of said 20 foot drainage easement

Second 20 ft. drainage easement:

Said 20 foot drainage easement is tangent to and 10 feet left and right of the following described centerline:

Beginning at a point in the centerline of Morgan Road, said point being the southwest corner of a 0.9312 acre tract conveyed to Leonard F. Kramer by official record 81 page 893, also being the south east corner of a 5.132 acre tract conveyed to Paul R. and Cathy E. Stephenson by Volume 297 Page 465

Thence, with the line between said 0.9312 and 5.132 acre tracts North 35 deg. 12 min. 32 sec. West a distance of 20.00 feet to a point in the northwest right-of-way line of said Morgan Road

Thence, with said right-of-way line North 55 deg. 0 min. 0 sec. East a distance at 23.86 feet to the true point beginning of said centerline drainage easement

Thence, across said 0.9312 acre tract, North 31 deg. 05 min. 04 sec. West a distance of 198.46 feet to a point in the northwest line of said Tract

The following described 4.3067 acre tract situated in state of Ohio, Madison County, Jefferson Township, VMS 2680, being part of a 6.2248 acre tract conveyed to Herbert J. and Dorothy A. Rice by Volume 250, Page 257 and being more particularly described as follows:

Beginning at a mag nail set in the centerline of Morgan Road (40 foot right-of-way) (County Road 46) said mag nail being at the southwest corner of a 5.1475 acre tract conveyed to John R. and Cinnamon Swaney by official record 107, Page 1638

Thence, with said centerline, South 55 deg. 00 min. 00 sec. West a distance of 268.94 feet to a ¾" Square Harrow Tooth found at the southeast corner of a 0.07 acre tract conveyed to Leon F. Creamer by official record 81 page 893

Thence, with the northeast line of said 0.07 acre tract, also the northeast line of a 0.9312 acre tract conveyed to Leon F. Creamer by official record 81 page 893, North 35 deg. 12 min. 32 sec. West, passing an iron pin and cap set at 20.00 feet, also passing an iron pin and cap set at the northern most corner of said 0.9312 acre tract at 218.00 feet, a total distance of 698.65 feet to an iron pin cap set in the south line of a 177.489 acre tract conveyed to Robert Jr. and Adeline Wilson by Volume 200 page 86 said iron pin and cap is also in the line between VMS 6643 and to 2680

Thence, with said line North 54 deg. 43 min. 26 sec. East a distance of 267.60 feet to an iron pin cap previously set at the northwest corner of said Swaney's 5.1475 acre tract

Thence, with the south west line of said 5.1475 acre tract, South 35 deg. 19 min. 05 sec. East passing an iron pin and cap previously set at 679.95 feet, a total distance of 699.95 feet returning to the point beginning containing 4.3067 acres more or less.

First 20 foot drainage easement:

Said 20 foot drainage easement is tangent to and 10 feet left and right of the following described centerline:

Beginning at a mag nail set in the centerline of Morgan Road (40 foot right-of-way) (County Road 46) said mag nail being at the southwest corner of a 5.1475 acre tract conveyed to John R. and Cinnamon Swaney by official record 107 Page 1638, said mag nail also being corner to said 6.2248 acre tract

Thence, with the southwest line of said 5.1475 acre tract, North 35 deg. 19 min. 05 sec. West, passing an iron pin cap previously set at 20.00 feet, a total distance of 370.26 feet to the true point beginning of the centerline of said 20 foot drainage easement

Thence, North 86 deg. 16 min. 35 sec. West a distance of 401.49 feet to a point in the centerline of a swale and the western terminus of said 20 foot drainage easement

Second 20 ft. drainage easement:

Said 20 foot drainage easement is tangent to and 10 feet left and right of the following described centerline:

Beginning at a point in the centerline of Morgan Road, said point being the southwest corner of a 0.9312 acre tract conveyed to Leonard F. Kramer by official record 81 page 893, also being the south east corner of a 5.132 acre tract conveyed to Paul R. and Cathy E. Stephenson by Volume 297 Page 465

Thence, with the line between said 0.9312 and 5.132 acre tracts North 35 deg. 12 min. 32 sec. West a distance of 20.00 feet to a point in the northwest right-of-way line of said Morgan Road

Thence, with said right-of-way line North 55 deg. 0 min. 0 sec. East a distance at 23.86 feet to the true point beginning of said centerline drainage easement
