

Description or 3.7171 acre tract Surveyed for Steve Isaacs

The following described 3.7171 acre tract is situated in the state of Ohio, Madison County, Pleasant Township, V.M.S. 4208, being part of a 7.787 acre tract conveyed to Steven M. and Cheryl B. Isaacs by official record 67 p. 85 and being more particularly described as follows:

Beginning at a concrete nail set at the centerline intersection of state Route 56 with the centerline of Anderson -Antioch Road (County Road 59) said nail is also at the southernmost corner of said 7.787 acre tract

Thence, with the centerline state Route 56 the following two courses:

- 1) with a curve to the left said curve having a radius of 7813.06 feet, arc length of 215.25 feet, and chord bears North 59 deg. 58 min. 55 sec. West a chord length of 215.25 feet
- 2) North 60 deg. 46 min. 16 sec. West a distance of 278.91 feet to the southeast corner of a 5.98 acre tract conveyed to Marilyn A. Reay by official record 123 page 846

Thence, with the line between said 5.98 and said 7.787 acre tract North 38 deg. 16 min. 08 sec. East, passing an iron pin cap set at 94.86 feet a total distance of 361.45 feet to an iron pin and cap set

Thence, across said 7.787 acre tract South 55 deg. 35 min. 11 sec. East, passing an iron pin cap set of 435.67 feet, a total distance of 465.04 feet to a mag nail set in the centerline of Anderson-Antioch Road

Thence, with said centerline, South 33 deg. 52 min. 00 sec. West a distance of 318.94 feet returning to the point beginning containing 3.7171 acres more or less

Bearings are based on the centerline of Anderson - Antioch Road (South 33 deg. 52 min. West) as described in official record 67 p. 85.

The following described 4.1094 acre tract is situated in the state of Ohio, Madison County, Pleasant Township, V. M.S. 462 and 4208, and being part of a 7.787 acre tract conveyed to Steven M. and Cheryl B. Isaacs by official record 67 p. 85 and being more particularly described as follows:

Beginning at a concrete nail set at the centerline intersection of state Route 56 with the centerline of Anderson-Antioch Road (County Road 59) said nail being at the southernmost corner of said 7.787 acre tract

Thence, with the centerline of Anderson-Antioch North 33 deg. 52 min. 00 sec. East a distance of 318.94 feet to a mag nail set in said centerline at the **True Point of Beginning**

Thence, with a new line across said 7.787 acre tract North 55 deg. 35 min. 11 sec. West, passing iron pin cap set at 29.37 feet, a total distance of 465.04 feet to an iron pin cap set in the east line of 5.98 acre tract conveyed to Marilyn A. Reay by official record 123 page 846

Thence, with said 5.98 acre tract North 38 deg. 16 min. 08 sec. East a distance of 406.90 feet to a 10 inch wood fence post found

Thence, continuing with said 5.98 acre tract and also with a 7.51 acre tract also conveyed to Marilyn A. Reay by official record 123 page 846, North 86 deg. 56 min. 01 sec. East a distance of 179.57 feet to a half-inch iron pipe found at the northwest corner of a 1.100 acre tract conveyed to Carma J. and Robert Armentrout by official record 102 Page 2611

Thence, with said 1.100 acre tract the following two courses:

- 1) South 00 deg. 07 min. 09 sec. East a distance of 236.34 feet to a half-inch iron pipe found
- 2) South 58 deg. 32 min. 15 sec. East, passing an iron pin cap set at 133.26 feet a total distance a 158.28 feet to a mag nail set in the centerline of Anderson-Antioch Road

Thence, with said centerline South 33 deg. 52 min. 00 sec. West a distance of 328.71 feet returning to the **True Point of Beginning** containing 4.1094 acres more or less
