Thence, across said 34.3988 acre tract the following two new courses:

1) South 40 deg. 47 min. 48 sec. West a distance of 39.82 feet to an iron pin and cap set

2) North 40 deg. 07 min. 10 sec. West a distance of 13.49 feet to a three-quarter inch diameter iron pipe found at the south west corner of said 6.4263 acre tract;

Thence, with the south line of said 6.4263 acre tract, North 60 deg. 15 min. 37 sec. East a distance of 39.97 feet returning to the true point beginning containing 0.0061 acres more or less.

Beginning at a PK nail found in the centerline of Taylor-Blair Road (CR 14)(50 ft. right-of-way) said nail is at the northern most corner of said 6.4263 acre tract, also the eastern most corner of a 2.00 acre tract conveyed to Richard L. Daylong by Volume 295 Page 619;

Thence, with said centerline, the following two courses:

- 1) South 39 deg. 03 min. 34 sec. East a distance of 78.56 feet to a PK nail found
- 2) South 36 deg. 06 min. 25 sec. East a distance of 213.26 feet to a PK nail found in said centerline at the northern most corner of the Jefferson Township Cemetery;

Thence, with said cemetery, the following three courses:

- 1) South 55 deg. 32 min. 03 sec. West, passing an a 1/2 inch iron pipe found at 33.16 feet, a total distance of 267.70 feet to a three-quarter inch iron pipe found
- 2) South 31 deg. 34 min. 33 sec. East a distance of 122.81 feet to a three-quarter inch iron pipe found
- 3) North 55 deg. 11 min. 57 sec. East, passing a three-quarter inch iron pipe found at 240.37 feet, a total distance of 272.12 feet to a PK nail found in the centerline of Taylor-Blair Road;

Thence, with said centerline, South 31 deg. 32 min. 41 sec. East a distance of 110.37 feet to a concrete nail and washer set;
