Thence, with the line between said 26.495 and said 35.9148 acre tract, South 00 degrees 49 min. 07 sec. West, passing an iron pin and cap set at 25.00 feet, a total distance of 600.00 feet to an iron pin and cap set in said line;

Thence, across said 26.495 acre tract with the following two new courses:

1) North 88 degrees 07 min. 39 sec. West a distance of 183.15 feet to an iron pin and cap set

2) North 01 deg. 57 min. 47 sec. West, passing an iron pin and cap set at 575.56 feet, a total distance of 600.62 feet to a concrete nail and washer set in the centerline of said Pringle-Benjamin Road;

Thence, with said centerline, South 88 deg. 17 min. 40 sec. East a distance of 212.30 feet returning to the point beginning containing 2.7218 acres more or less.
