


NOTE: Monumentation as called for in current deed for Carr Farms, Ltd, was unable to be recovered. Monument calls were to natural objects which have since been destroyed. On 11-7-03 our firm met with Ronald E. Howard, owner of a 157.17 Ac. tract and partner of M&E Family, LLC. Both tracts have a common property line with said 130.914 Ac. tract. Ronald pointed out the wood & steel posts and confirmed that these posts marked his property corners. Mr. Howard has farmed this land for over thirty—five years. He explained that at one time there was an old fence line marking said property lines, which he had removed and installed wood & steel posts. From this testimony and other found monumentation, property lines have been set as

thence southwesterly along the north line of said 61.297 acre tract, and along an old fence line, South 54° 58' 53" West, 2675.29 feet to an iron pin found, being the TRUE POINT OF BEGINNING:

thence southerly along the west line of said 61.297 acre tract, South 40° 41' 24" East, 97.48 feet to a wood post found;
