

Beginning at a 1/2 inch iron pipe found in the centerline of Fralick Road (45 ft. right-of-way) (Township Road 86), said iron pipe is at the northeast corner of a 9.01 acre tract conveyed to Karen M. Kirby by official record 3 page 945;

Thence, with said 9.01 acre tract the following 2 courses:

- 1) North 88° 53 minutes 15 seconds West, passing a 5/8 inch diameter rebar and plastic caps stamped "McCarty and Associates" found at 19.78 ft., 1022.48 ft., and 1197.92 ft., a total distance of 1253.39 ft.
- 2) South 03° 06 minutes 11 seconds West a distance of 313.24 ft. to an iron pin found
