

Legal Description 102.750 acres

The following described tract of land is situated in the State of Ohio, Madison and Franklin Counties, Canaan and Brown Townships, VMS 1618, VMS 7693, being all of DWC Holdings, an Ohio Limited Liability Corporation's 99 acre and 1/3 acre tract described in Madison County Official Record 540, page 869 and Franklin County instrument number 200406110135619 and being more particularly described as follows:

Commencing at a mag nail set at the intersection of the centerline of Carters Mill Road with the centerline of Hayden Run Road (C.R.#38)(45');

thence North 58°06'00" East 2720.00 feet, following the centerline of Hayden Run Road, to a mag nail set at the southwest corner of said 99 acre tract and at the southeast corner of Lloyd Roby's 67.16 acre tract described in Deed Volume 277, page 77, said mag nail marking the point of beginning;

thence North 32°32'38" West 3358.81 feet, following the west line of said 99 acre tract, the east line of said 67.16 acre tract, the east line of Betty O. Roby Life Estate's 67.16 acre tract described in Deed Volume 274, page 899, passing at 20.00 feet an iron pin set and passing at 1236.57 feet an 8" wood post found, to an 8" wood post found in the south line of Don and Collette I. Whitmer's 42.68 acre tract described in Deed Volume 228, page 466, said post being in the north line of VMS 1618:

thence North 58°07'01" East 1320.78 feet, following the north line of said 99 acre tract and the south line of said 42.68 acre tract, to an iron pin set in place of an 8" wood post found (down)at the northwest corner of Donald E. and Julienne S. Seely's 150.04 acre tract described in Madison County Official Record 268, page 741 and Franklin County instrument number 07114F14;

thence South 32°45'36" East 2658.41 feet, following the east line of said 99 acre tract and the west line of said 150.04 acre tract, to a 2 ½" iron post found at the northwest corner of Wayne and Mary Alice Becker's 44.80 acre tract described in Official Record 3214, page 323;

thence South 32°33'08" East 705.90 feet, following the east line of said 99 acre tract and the west line of said 44.80 feet, to a 3" angle iron post found (broken off at the ground), said post being in the south line of VMS 1618;

thence South 58°34'04" West 430.98 feet, following the south line of said 99 acre tract, the north line of said 44.80 acre tract and the south line of VMS 1618, to an iron pin set at the northeast corner of said 1/3 acre tract;

thence South 02°52'30" East 147.48 feet, following the east line of said 1/3 acre tract and the west line of said 44.80 acre tract, passing at 114.41 feet an iron pin set, to a mag nail set in the centerline of Hayden Run Road;

thence North 88°53'46" West 240.85 feet, following the centerline of Hayden Run Road and the south line of said 1/3 acre tract, to a ¾" iron pipe found in the south line of said 99 acre tract:

thence South 58°06'00" West 626.47 feet, following the centerline of said Hayden Run Road and the south said 99 acre tract, to the point of beginning, containing 102.750 acres, more or less, 96.660 acres in Madison County, 6.090 acres in Franklin County, 0.407 acres in VMS 7693 and 102.343 acres in VMS 1618. Subject to all valid easements and restrictions of record.
