

10.6903 Acre Tract Surveyed for Peggy Davis

Beginning at a railroad spike found in the centerline of Junk Road (County Road 21)(40 ft. right-of-way), said railroad spike is at the southeast corner of a 2.8926 acre tract conveyed to Peggy Ann Davis by official record 36 page 508;

Thence, with said 2.8926 acre tract the following 2 courses:

- 1) North 01 degree 16 minutes 18 seconds East, passing an iron pin and cap previously set at 25.00 ft., a total distance of 600.00 feet to iron pin and cap previously set
- 2) North 88° 44 minutes 24 seconds West a distance of 210.00 ft. to an iron pin and cap previously set at the northwest corner of said 2.8926 acre tract;

Thence, across said original 268.70 acre tract the following 3 new courses:

- 1) North 01 degree 16 minutes 18 seconds East a distance of 536.35 feet to an iron pin and cap set
- 2) South 88° 44 minutes 24 seconds East a distance of 521.08 ft. to iron pin and cap set
- 3) South 01 degree 18 minutes 46 seconds West, passing an iron pin and caps set at 329.98 ft. and 1112.30 ft., a total distance of 1136.35 feet to a mag nail set in the centerline of said Junk Road

Thence, with the centerline of said Junk Road, North 88° 44 minutes 24 seconds West a distance of 310.27 ft. returning to the point beginning containing 10.6903 Acres more or less.

Beginning at a railroad spike found in the centerline of Junk Road (County Road 21)(40 ft. right-of-way), said railroad spike is at the southwest corner of a 3.591 acre tract conveyed to Dean and Faith L. Marshall by deed book 253 page 1;

Thence, with the centerline of said Junk Road, North 88° 43 minutes 07 seconds West a distance of 438.21 ft. to a mag nail set in said center line;

Thence, across said 268.70 original acre tract, the following 3 new courses:

- 1) North 00 degree 38 minutes 07 seconds East, passing iron pin and cap set at 25.40 ft., a total distance of 1102.25 ft. to an iron pin and cap set;
- 2) South 88° 43 minutes 42 seconds East a distance of 563.60 ft. to an iron pin and cap set
- 3) South 00 degree 38 minutes 07 seconds West a distance of 631.36 ft. to an iron pin and cap set at the northwest corner of said Marshall's 3.591 acre tract;

Thence, with the west line of said 3.591 acre tract, South 15° 35 minutes 10 seconds West, passing an iron pin and cap set at 459.88 ft., a total distance of 486.02 ft. returning to the point beginning containing 13.5834 Acres more or less.
