Thence, with the northwest line of said 7.762 acre tract, North 41° 26 minutes 22 seconds East, passing the southernmost corner of a 2.726 acre tract conveyed to Elizabeth Blakeslee by Official Record 202 page 1221 at 27.89 ft., also passing an iron pin and cap set at 610.67 ft., a total distance of 631.86 ft. to a point in the centerline of said State Route 56;

Thence, with the centerline of said State Route 56, South 41° 30 minutes 00 seconds East a distance of 246.23 ft. to the northernmost corner of a 1.41 acre tract conveyed to Vancil and Ruth Comer by Deed Book 296 page 628;

Thence, with said 1.41 acre tract the following 2 courses:
