


Situate in Virginia Military Survey No. 8846, Union Township, County of Madison, State of Ohio, and being 6.694 acres of land all out of that 200.79 acre tract of land owned by Madison County Investors, Inc., of record in Official Record Volume 212, Page 402 (all references to records being on file in the Office of the Recorder, Madison County, Ohio), said 6.694 acre tract of land being further described as follows:

The Point of Reference being a P.K. nail set at the northeasterly corner of said 200.79 acre tract, being in the centerline of State Route 56, at the intersection with the centerline of Old Xenia Road, and being the northerly corner of that 2.497 acre tract of land owned by The First Church of God of London, Inc., of record in Official Record Volume 246, Page 263; Thence South 20°00'00" West, along the centerline of Old Xenia Road, being the easterly line of said 200.79 acre tract, and being the westerly line of said 2.497 acre tract, and the westerly line of that 1.844 acre tract of land owned by David Shane Manning, of record in Official Record Volume 268, Page 596, a total distance of 704.23 feet to a P.K. nail set and being The True Place of Beginning of the herein described 6.694 acre tract, passing railroad spikes found at a distance of 438.35 feet and 468.35 feet;

Thence South 20°00'00" West, along the easterly line of said 200.79 acre tract, being the centerline of Old Xenia Road, and along the westerly line of said 1.844 acre tract, and along the westerly line of a 158.24 acre tract of land owned by Mary E. Situate in Virginia Military Survey No. 8846, Union Township, County of Madison, State of Ohio, and being a 0.169 acre Drainage Easement, all out of that 200.79 acre tract of land owned by Madison County Investors, Inc., of record in Official Record Volume 212, Page 402 (all references to records being on file in the Office of the Recorder, Madison County, Ohio), said 0.169 acre Drainage Easement being further described as follows:

The Point of Reference being a P.K. nail set at the northeasterly corner of said 200.79 acre tract, being in the centerline of State Route 56, at the intersection with the centerline of Old Xenia Road, and being the northerly corner of that 2.497 acre tract of land owned by The First Church of God of London, Inc., of record in Official Record Volume 246, Page 263; Thence South 20°00'00" West, along the centerline of Old Xenia Road, being the easterly line of said 200.79 acre tract, and being the westerly line of said 2.497 acre tract, and the westerly line of that 1.844 acre tract of land owned by David Shane Manning, of record in Official Record Volume 268, Page 596, a distance of 1065.59 feet to a P.K. nail set at the southerly corner of a proposed 6.694 acre tract, passing railroad spikes found at a distance of 438.35 feet and 468.35 feet;

Thence North 28°20'47" West, into of said 200.79 acre tract, and along the southwesterly line of a proposed 6.694 acre tract, a distance of 712.92 feet to The True Place of Beginning of the herein described 0.169 acre Drainage Easement, and passing an iron pin set in the westerly Right-of-Way line of said Old Xenia Road at a distance of 40.19 feet;

Thence North 28°20'47" West, continuing along the southwesterly line of said proposed 6.694 acre tract, a distance of 25.38 feet to a point;

Thence North 51°46'22" East, into said proposed 6.694 acre tract, a distance of 192.05 feet to a point of curvature;

Thence 63.40 feet along the arc of a curve to the left, having a radius of 87.50 feet, a central angle of 41°30'45", the chord of which bears North 31°01'00" East, a chord distance of 62.02 feet to a point of tangency;

Thence North 10°15'37" East, a distance of 43.98 feet to a point in the northeasterly line of said proposed 6.694 acre tract;
