Miller and Wilma Miller, Trustees...fronting along the middle of Finley-Guy County Road # 123...said 1.6149 acres is bounded and more particularly described as follows:

For a starting reference commence with a spike located in the middle of Lafayette-Plain City Road and the projected centerline of Finley-Guy Road, go then along the middle of Finley-Guy Road in a westerly direction 3,550.160 feet to a set mag spike at the true point of beginning:

Thence: Leaving the road at a right angle and passing a set 5/8 inch capped rebar at 27.606 feet go 3 22 deg 00 min 00 sec W û total distance of 351.715 feet to a set 5/8 inch capped steel rod;

Thence: Parallel with aforesaid roadway go N 68 deg 00 min 00 sec W 200.000 feet to a 5/8 inch capped steel rod set;

Thence: Passing a set 5/8 inch capped steel rod at 324.601 feet go N 22 deg 00 min 00 sec E 351.715 feet to a set mag spike in the middle of Finley-Guy Road, this spike being 675.110 feet S 68 deg 00 min 00 sec E as measured along the centerline from a found spike where the boundary between VMS 7791 and VMS 12275 crosses Finley-Guy road and this VMS boundary is 185.60 feet (same bearing) from where the boundary between Monroe Township and Canaan Township crosses said road;

Thence: Following the middle of Finley-Guy Road with the herein described frontage boundary go S 68 deg 00 min 00 sec E 200.000 feet to the true point of beginning.
