



LEGAL DEED DESCRIPTION RON WINN 1.987 ACRES'

Real estate situated in Monroe Township of Madison County, Ohio; in the Virginia Military Survey numbers 7924 and 5483; being part of the original 213.90 acre tract of Ron Winn (Official Record 193, page 321); and being further bounded and described as follows:

Beginning for reference at a survey nail found at the centerline intersection of Mechanicsburg-Sanford Road (County Road 27) and David Brown Road (County Road 119).

Thence with four consecutive courses of said centerline of Mechanicsburg-Sanford Road:

- 1) South 73 deg.-24'-52" East, 1770.74 feet to a point.
- 2) North 69 deg.-18'-22" East, 1767.90 feet to an iron rod found at the southwest corner of said original 213.90 acre tract.
- 3) North 67 deg.-09'-19" East, 2100.00 feet to an iron pipe found.
- 4) North 88 deg.-29'-46" East, 296.88 feet to a survey nail found at the southeast corner of the 2.733 acre tract of J.L. and J.W. Beach (Official Record 215, page 1808), being the True Point of Beginning.

Thence North 10 deg.-08'-39" East, 552.46 feet along the east line of said tract (passing over an iron pipe found at 30.63 feet) to an iron pipe found on a south line of a 20.001 acre tract surveyed this date.

Thence North 88 deg.-29'-46" East, 160.00 feet along said south line (passing over an iron pipe found on a southwest corner of the 20.001 acre tract of R.S. and M.V. Riegel, Official Record 220, page 1549, at 127.26 feet) to an iron pipe found at another corner of said 20.001 acre tract of Riegel.

Thence South 10 deg.-08'-39" West, 552.46 feet along a west line of said 20.001 acre tract of Riegel (passing over an iron pipe found at 521.83 feet) to a survey nail found in said centerline of Mechanicsburg-Sanford Road.

Thence South 88 deg.-29'-46" West, 160.00 feet along said centerline to the True Point of Beginning.

Bearing was assumed from grantor's deed. The tract as described from an actual field survey performed on or about February 23, 2007, by Registered Surveyor Joseph P. Priday (S-7277), contains 1.987 acres, more or less, subject to all previous easements and rights-of-way of record. All iron pipes set are 3/4" x 30" galvanized pipe with plastic I.D. caps. Beginning for reference at a survey nail found at the centerline intersection of Mechanicsburg-Sanford Road (County Road 27) and David Brown Road (County Road 119).

Thence with four consecutive courses of said centerline of Mechanicsburg-Sanford Road:

- 1) South 73 deg.-24'-52" East, 1770.74 feet to a point.
- 2) North 69 deg.-18'-22" East, 1767.90 feet to an iron rod found at the southwest corner of said original 213.90 acre tract.
- 3) North 67 deg.-09'-19" East, 2100.00 feet to an iron pipe found.
- 4) North 88 deg.-29'-46" East, 15.62 feet to an iron pipe set, being the True Point of Beginning.

Thence North 10 deg.-08'-39" East, 552.46 feet (passing over an iron pipe set at 30.63 feet) to an iron pipe set.

Thence North 06 deg.-13'-45" East, 2055.95 feet to an iron pipe set on a southwesterly line of the remaining portion of tracts 4 and 5 of Woodland Farms, Inc. (Deed Record 154, page 45).

Thence with two consecutive courses of said centerline of Mechanicsburg-Sanford Road:

- 1) South 73 deg.-24'-52" East, 1770.74 feet to a point.
- 2) North 69 deg.-18'-22" East, 1767.90 feet to an iron rod found at the southeasterly corner of the original 350.57 acre tract of Flora Booth Tyson (Deed Record 149, page 334). Also being the southwesterly corner of said original 213.90 acre tract.

Thence North 67 deg.-09'-19" East, 600.00 feet continuing along said centerline of Mechanicsburg-Sanford Road to a survey nail found at the southeasterly corner of a 1.628 acre lot, known as Tract 7 (surveyed 3-18-05), being the TRUE POINT OF BEGINNING.

Thence North 10 deg.-30'-00" East, 565.91 feet along the easterly line of said Tract 7 (passing over an iron pipe found at 35.91 feet) to an iron pipe found.

Thence South 67 deg.-09'-19" West, 600.00 feet along the northerly line of said Tract 7, and the northerly lines of Tract 8, and two additional 1.628 acre lots (surveyed 01-03-06), to an iron pipe found on the easterly line of said original 350.57 acre tract.

Thence with two consecutive courses of said original 350.57 acre tract:

- 1) North 10 deg.-30'-00" East (assumed bearing), 3190.81 feet to an iron pipe set.
- 2) North 57 deg.-32'-30" East, 1401.00 feet to an iron pipe set on a westerly corner of the 16.3 acre tract of Woodland Farms, Inc. (Deed Record 154, page 45).

Thence South 67 deg.-09'-19" West, 880.00 feet along the northerly lines of Tracts 1 through 6 to an iron pipe found on the northwesterly corner of Tract 6.

Thence with two consecutive courses on said Tract 6:

- 1) South 10 deg.-30'-00" West, 459.98 feet to an iron pipe found.
- 2) South 12 deg.-50'-41" East, 89.86 feet (passing over an iron pipe found at 59.40 feet) to a survey nail found in said centerline of Mechanicsburg-Sanford Road.

Thence South 67 deg.-09'-19" West, 114.45 feet along said centerline to the TRUE POINT OF BEGINNING.
