

DESCRIPTION OF 0.936 ACRES FROM LANDS OWNED BY MARTHA GITTINS BRICKER PLEASANT TOWNSHIP, MADISON COUNTY, OHIO

Situate in Virginia Military Survey No. 7883, and Virginia Military Survey No. 464, Pleasant Township, County of Madison, State of Ohio, and being 0.936 acres of land all out of a 149.04 acre tract of land owned by Martha Gittins Bricker, of record in Official Record Volume137, Page 229 (all references to records being on file in the Office of the Recorder, Madison County, Ohio), said 0.936 acre tract being further described as follows:

The True Place of Beginning being a solid iron pin found at the northwesterly corner of said 149.04 acre tract, being a southwesterly corner of that 11.42 acre tract of land owned by Gerald T. Baynes, of record in Official Record Volume, 181, Page 445, and identified therein as Third Tract, being near the monumented centerline of State Route 56 (60' wide).

Thence South 45°28'07" East, along the westerly line of said 149.04 acre tract, being generally along the centerline of State Route 56, a distance of 25.00 feet to a point;

Thence North 45°06'22" East, into said 149.04 acre tract and being parallel with a northerly line of said 149.04 acre tract, and passing an iron pin set on the northeasterly Right-of-Way line of State Route 56 at a distance of 28.79 feet, a total distance of 718.13 feet to an iron pin set;

Thence North 69°52'16"East, and being parallel with a northerly line of said 149.04 acre tract, a distance of 1522.33 feet to an iron pin set in the westerly line of a 130 acre tract of land owned by Gerald T. Baynes, of record in Official Record Volume 181, Page 445, and identified therein as First Tract, and being in a north/south line of said 149.04 acre tract;

Thence North 18°12'51" West, along the westerly line of said 130 acre tract, being a line of said 149.04 acre tract, a distance of 15.01 feet to a point at the southeasterly corner of said 11.42 acre Third Tract, and being a northerly corner of said 149.04 acre tract;

Thence South 69°52'16" West, along a north line of said 149.04 acre tract, being a south line of said 11.42 acre tract, a distance of 1550.00 feet to a point;

Thence South 45°06'22"West, along a north line of said 149.04 acre tract, being a south line of said 11.42 acre tract, a distance of 700.00 feet to the True Place of Beginning and containing 0.936 acre of land, of which 0.401 acre lies within Virginia Military Survey No. 7883, and 0.535 acre lies within Virginia Military Survey No. 462.

For the purpose of this description, a bearing of South 42°28'07" East was used on the westerly line of that 149.04 acre tract of land owned by Martha Gittins Bricker, being generally along the centerline of State Route 56, of record in Official Record Volume137, Page 229, on file in the Office of the Recorder, Madison County, Ohio.
