Beginning at a railroad spike set over an iron pin found at the centerline intersection of Pancake Selsor Road (Township Road 90)(50 ft. right-of-way) with the centerline of Selsor-Moon Road (County Road 16)(50 ft. right-of-way) said railroad spike is also at the southeast corner of said 76 acre tract;

Thence, with the centerline of said Selsor-Moon Road, North 84° 26 minutes 18 seconds West a distance of 703.04 ft. to a mag nail set;

Thence, across said 76 acre tract the following 2 new courses:

- 1) North 08° 12 minutes 13 seconds East, passing an iron pin and cap set at 23.00 ft., a total distance of 721.25 ft. to an iron pin and cap set
- 2) South 82° 42 minutes 20 seconds East, passing an iron pin and cap set at 646.43 ft., a total distance of 666.15 ft. to a mag nail set in the centerline of said Pancake Selsor Road

Thence, with the centerline of said Pancake Selsor Road, South 05° 14 minutes 19 seconds West a distance of 700.35 ft. returning to the point beginning containing 11.1658 Acres more or less.



Beginning at a railroad spike set over an iron pin found at the centerline intersection of Pancake Selsor Road (Township Road 90)(50 ft. right-of-way) with the centerline of Selsor-Moon Road (County Road 16)(50 ft. right-of-way) said railroad spike is also at the southeast corner of said 76 acre tract;

Thence, with the centerline of said Selsor-Moon Road, North 84° 26 minutes 18 seconds West a distance of 703.04 ft. to a mag nail set at **The True Point Beginning**;

Thence, continuing with the centerline of said Selsor-Moon Road, North 84° 26 minutes 18 seconds West a distance of 762.80 ft. to a railroad spike set over an iron pin found at the southeast corner of a 66.88 acre tract conveyed to Clarence T. and Linda J. Hudson by Official Record 28 page 730;

Thence, with the east line of said 66.88 acre tract, North 05° 12 minutes 24 seconds East, passing an iron pin and cap set at 23.40 ft., also passing an angle iron fence post in concrete found at 2261.05 ft., a total distance 2262.11 ft. to an iron pin and cap set at the northeast corner of a 66.88 acre tract conveyed to Clarence T. and Linda J. Hudson by Deed Book 298 page 403, said iron pin and cap is also in the south line of a 50 acre tract conveyed to Clarence T. and Linda J. Hudson by official record 28 page 730;

Thence, with the south line of said 50 acre tract, South 84° 35 minutes 14 seconds East, passing an iron pin and cap set at 1447.76 ft., a total distance of 1467.08 ft. to a railroad spike set over an iron pin found in the centerline of said Pancake Selsor Road;

Thence, with the centerline of said Pancake Selsor Road, South 05° 14 minutes 19 seconds West a distance of 1565.57 ft. to a mag nail set in said centerline;

Thence, across said 76 acre tract the following 2 new courses:

- 1) North 82° 42 minutes 20 seconds West, passing an iron pin and cap set at 19.72 ft., a total distance of 666.15 ft. to an iron pin and cap set
- 2) South 08° 12 minutes 13 seconds West, passing an iron pin and cap set at 698.34 ft., a total distance of 721.25 ft. returning to **The True Point Beginning** containing 65.0519 Acres more or less.
