Thence North 87 degrees 04 minutes 45 seconds West 19.13 feet to an iron pin;

Thence North 55 degrees 44 minutes 55 seconds West 4.90 feet to a railroad spike at the southeast corner of a small tract owned by Charles and Deborah Deleon (OR 98 Page 2464);

Thence along the centerline of Lombard-Chuckery Road (County Road 29) North 57 degrees 36 minutes 00 seconds West 213.05 feet to a railroad spike buried in the center of the road at the southwest corner of the Deleon property;

Thence continue along the centerline of said road North 57 degrees 20 minutes 47 seconds West 410.17 feet to a P.K. nail.

Thence leaving said centerline North 11 degrees 44 minutes 20 seconds East 171.07 feet to a 5/8" rebar set with cap in the east line of the Zendall Gingerich property (Book 221, Pg.221) for the **True Point of Beginning** of the tract of land herein and hereby conveyed.

Thence continue through the Gingerich property North 11 degrees 44 minutes 20 seconds East 297.60 feet to a 5/8" rebar set in the north line of the Gingerich property.

Thence South 57 degrees 20 minutes 40 seconds East along the north line of the Gingerich property 106.25 feet to a 5/8" rebar set with cap at the Gingerich northeast corner.

Thence North 87 degrees 04 minutes 45 seconds West 19.13 feet to an iron pin;

Thence North 55 degrees 44 minutes 55 seconds West 4.90 feet to a railroad spike at the southeast corner of a small tract owned by Charles and Deborah Deleon (OR 98 Page 2464);

Thence along the centerline of Lombard-Chuckery Road (County Road 29) North 57 degrees 36 minutes 00 seconds West 213.05 feet to a railroad spike buried in the center of the road at the southwest corner of the Deleon property.

Thence continue along the centerline of said road North 57 degrees 20 minutes 47 seconds West 410.17 feet to a P.K. nail set for the Point of Beginning of the small tract herein and hereby conveyed.
