For reference commence with a found Mag Spike in the middle of M.V.High County Road # 44 (50 feet right of way width) at the common boundary between VMS 8696 and VMS 12743 go then along the middle of M.V.High Road S 83 deg 51 min 35 sec E 418.230 feet to a set mag spike at the point point of beginning which spike measures 5,308.065 feet easterly from the middle of junction of M.V.High Road and London-Delaware Road (U.S. Route # 42);

Thence: Leaving M.V.High Road and passing set rebars set at 20.000 feet and at 193.330 feet and again a rebar at 267.716 feet, bearing N 24 deg 17 min 15 sec E 298.024 feet to a capped steel rod set;

hence: Parallel with M.V.High Road go S 83 deg 51 min 35 sec E 239.092 feet to a capped steel rod set;

Thence: Passing a capped rebar set at 28.800 feet and crossing Chandler Ditch # 183 (open ditch type grass water way with County rights of maintenance and subject to property assessment) go with a bearing of S 06 deg 08 min 25 sec W 109.665 feet to a set 5/8 steel rod capped;
