Beginning at the intersection of the centerline of Shady Grove Road (Stokes Township Road 158) (40 ft. right-of-way)/ Pleasant View Road (Fayette County Road 95) with the Madison/Fayette County line, said intersection bears North 87° 56 minutes 39 seconds West a distance of 18.14 ft. from a County stone found;

Thence, with the centerline of said Shady Grove Road, North 02° 30 minutes 00 seconds East, passing a PK nail found at the intersection of Curry Road (County Road 81)(40 ft. right-of-way) at 249.24 ft., and continuing along the centerline of said Curry Road a total distance of 322.38 ft. to a mag nail set corner to a 43.9706 acre tract conveyed to John Mark Gossard by Official Record 99 page 2109(Madison County);

Thence, with said 43.9706 acre tract the following 2 courses:

- 1) North 88° 04 minutes 43 seconds East, passing an iron pin and cap set at 30.30 ft., a total distance of 478.25 ft. to a 3/4 inch diameter iron pipe found
- 2) South 03° 29 minutes 32 seconds West a distance of 355.65 ft. to an iron pin and cap set in the Madison/Fayette County line;

Thence, with a new line across said 8.6963 acre tract and the Madison/Fayette County line, North 87° 56 minutes 39 seconds West, passing a County stone found at 452.55 ft., also passing a 5/8 inch diameter solid iron pin found at 470.58 ft., a total distance of 470.69 ft. returning to the point beginning containing 3.6854 Acres more or less.

Beginning at the intersection of the centerline of Shady Grove Road (Stokes Township Road 158) (40 ft. right-of-way)/ Pleasant View Road (Fayette County Road 95) with the Madison/Fayette County line, said intersection bears North 87° 56 minutes 39 seconds West a distance of 18.14 ft. from a County stone found;

Thence, with a new line across said 8.6963 acre tract and said Fayette/Madison County line, South 87° 56 minutes 39 seconds East, passing a 5/8 inch diameter iron pin found at 0.11 ft., also passing a County stone found at 18.14 ft., a total distance of 470.69 ft. to an iron pin and cap set corner to a 5.9931 acre tract conveyed to John Mark Gossard, trustee by Official Record 46 page 694 (Fayette County);

Thence, with the west line of said 5.9931 acre tract, South 03° 29 minutes 32 seconds West a distance of 465.09 ft. to a 3/4 inch diameter iron pipe found in the north line of a 40.00 acre tract conveyed to Ronald W. Sears by Official Record 92 page 976;

Thence, with the north line of said 40.00 acre tract, North 88° 44 minutes 09 seconds West, passing a 3 in. diameter metal fence post found in concrete 0.7 ft. left of line at 441.34 ft., a total distance of 462.73 ft. to a mag nail set over an iron pin found in the centerline of said Pleasant View Road;

Thence, with the centerline of said Pleasant View Road, North 02° 30 minutes 00 seconds East a distance of 471.35 ft. returning to the point beginning containing 5.0149 Acres more or less.
