From a spike found in the centerlines of Glade Run Road and Sparling Road on the boundary between Deer Creek Township and Union Township...go then northerly along the middle of Glade Run Road 2600.995 feet to a boat spike; then leaving said roadway and passing a steel pin at 25.00 feet go N 66 deg 27 min 06 sec E 1817.118 feet to a pin at the true point of beginning;

Thence: N 23 deg 02 min 35 sec W 339.880 feet to a steel pin;

Thence: N 88 deg 13 min 06 sec E 2112.363 feet to a pin;

Thence: S 00 deg 16 min 40 sec E 956.416 feet to a point in a open ditch (passing a fence junction corner post at 929.21 feet);

Thence: N 86 deg 09 min 18 sec W 1772.280 feet to a corner post; (specific to a 5/8 inch steel rebar corner);
