

#### **DESCRIPTION OF AN 11.9299 ACRE TRACT**

Situated in the State of Ohio, County of Madison, Township of Jefferson, Virginia Military Survey No. 2836 and 2445, and being a part of an 87.1535 acre tract of land in the name of Possumbilities LLC as described in Official Record 225, Page 272, all references are to the Recorder's Office, Madison County, Ohio:

Beginning at a 1" inside diameter iron pipe found in the northerly line of V.M.S. 2445 at the southeasterly corner of V.M.S. 8480, also being the southerly most corner of V.M.S 2836 and the easterly most corner of a 6.383 acre tract in the name of Jefferson Local School District as described in O.R. 152, Page 1457, said point being the *True Point of Beginning* of herein described tract;

Thence N 31°04′04″W, a distance of 866.69 feet (passing an 5/8″ iron rebar with cap found 0.20 feet west of line at 542.61 feet) along the easterly line of said 6.383 acre tract and then the easterly line of a 7.311 acre tract of land in the name of Mary Esther and George Brooke as described in Deed Book 155, Page 175 to a ¾″ inside diameter iron pipe found with cap stamped "Raab P.S. 7863" at a southwesterly corner of a 84.9125 acre tract of land in the name of Sovereign Communities, Inc. as described in Official Record 225, Page 238;
