Beginning at a mag nail set in the centerline of Cemetery Road (County Road 34)(40 ft. right-of-way) said mag nail is at the northernmost corner of said 0.45 acre tract and the westernmost corner of a 0.509 acre tract conveyed to Kenneth S. and Elen B. Sims by Official Record 204 page 1083;

Thence, with the southwest line of said 0.590 acre tract South 32° 56 minutes 43 seconds East, passing a 3/4 inch tee bar and cap at 20.08 feet, a total distance of 159.53 ft. to an iron pin and cap set at the southern corner common to said 0.509 and said 0.45 acre tracts;

Thence, across said 5.5569 acre tract the following 2 new courses:

- 1) South 32° 56 minutes 43 seconds East a distance of 63.65 ft. to an iron pin and cap set
