The following is a correct boundary description of existing residual acreage of 32.788 acres in Canaan Civil Township, Madison County, State of Ohio in VMS 7791 and being the remainder of P.P.N.01-00563.000 the same being shown as aerial parcel # 271, estate of Amanda Hostetler fronting along the southeasterly side of Lafayette-Plain City Road, bounded and more particularly described as follows:

Commence for a point of starting reference with a found railroad spike buried in the middle of A.W.Wilson Road and Lafayette-Plain City Road, go then with the middle of Lafayette-Plain City Road 5 47 deg 00 min 00 sec W 535.380 feet to a set nail at the true point of beginning;

Thence: Leaving said roadway and passing a set rebar at 25.919 feet S 35 deg 40 min 47 sec E 311.029 feet to a set rebar;

Thence: N 49 deg 02 min 22 sec E 339.210 feet to a found steel rod;

Thence: S 36 deg 01 min 38 sec E 1078.580 feet to a found steel pin;

Thence: S 11 deg 27 min 20 sec E 75.064 feet to an existing steel pin in a pile of broken concrete;

Thence: S 75.deg 46 min 23 sec W 1438.822 feet to a found iron pin;

Thence: N 35 deg 37 min 13 sec W (passing an existing steel pin at 741.760 feet) a total distance of 768.960 feet to a found P.K. spike in the middle of Lafayette-Plain City Road;

Thence: With the centerline of said roadway N 47 deg 00 min 00 sec E 1033.240 feet to the point of beginning.

Containing within said bounds 32.788 acres of land. Rebars set are covered with plastic caps stamped R.I.Baker S-5539.

Bearings are based on  $\,$  N 47 deg 00 min 00 sec E in center of Lafayette-Plain City Road ( 50 feet wide right of way and aka Co. Rd. # 5 ) see Deed Book 259 at Page 088.
