



The split is located in Virginia Military Survey (VMS) 13333, Deer Creek Township, Madison County, State of Ohio, on the west side of Lafayette-Plain City Road (County Road 5, 60 foot right-ofway) approximately 2000 feet south of Dunn Road and is further described as follows:

Commencing at an iron monument located at the intersection of Dunn Road and Lafayette-Plain City Road at the northeast corner of a property in the name of Donald L and Teri A Hahn (Deed Book 284, Page 900);

Thence S04°02'11"W, 451.37 feet, continuing along the centerline of Lafayette-Plain City Road and the east line of the said Wilson property, to a MAG Nail found at the southeast corner of said property in the south line of Virginia Military Survey 13333 and the north line of VMS 12142 and 12153, said MAG Nail is N71°41'00", 26.19 feet, from a steel angle iron fence post;

Thence N71°41'00"W, 129.27 feet, along the south line of the said Wilson property and VMS 13333 and the north line of a property in the name of the Roman Catholic Bishop of the Diocese of Columbus (Deed Book 280, Page 720), passing a broken concrete post at 24.77 feet (post is 0.71 feet left of the line) and an iron pin set in the west Right-of-way of Lafayette-Plain City Road at 30.96 feet, to a 6 inch diameter iron fence post;
