
Plat of Survey For Noah Beachy Farms, LTD State of Ohio, County of Madison Township of Darby, V.M.S. 1479

The following described 4.359 acre tract is situated in the State of Ohio, County of Madison, Township of Darby, V.M.S. 1479, being part of Noah Beachy Farms, LTD's original 50.000 acre tract described in Official Record 179, page 1913, and said 4.359 acre tract being more particularly described as follows:

Commencing at a point in the centerline of Iams Road (C.R. 35, 50 foot R/W), said point being in the northeast line of V.M.S. 1479, at the south corner of V.M.S. 3460, and at the west corner of V.M.S. 14150 & 14400;

Thence following the centerline of Iams Road, the northeast line of V.M.S. 1479, and the southwest line of V.M.S. 3460, to a steel nail found at the southeast corner of said original 50.000 acre tract and at the northeast corner of Joseph O. and Ada A. Beachy, Trustees' 2.000 acre tract described in Official Record 236, page 1091, and said nail marking the place of beginning;

Thence South 57°13'38" West 500.00 feet, departing from the centerline of Iams Road, following the southeast line of said original 50.00 acre tract and the northwest line of said 2.000 acre tract, passing at 22.02 feet a 3/4 inch iron pipe found with cap marked "R.I. BAKER S5539" and passing at 386.21 feet a 3/4 inch iron pipe found with cap marked "PRIDAY S7277" at the northwest corner of said 2.000 acre tract and at a northeast corner of Joseph O. and Ada A. Beachy, Trustees' original 98 acre tract described in Deed Record 224, page 362, thereafter following a northwest line of said original 98 acre tract to an iron pin set;

Thence North 32°30'00" West 379.23 feet, entering said original 50.000 acre tract, to an iron pin set;

Thence North 57°06'15" East 500.00 feet, continuing through said original 50.000 acre tract and passing at 100.10 feet a 5/8 inch iron pin found with cap marked "R.I.BAKER \$5539" at the southwest corner of Noah Beachy Farms, LTD's 1.8365 acre Parcel No. 1 described in Official Record 248, page 607, thereafter following the southeast line of said 1.8365 acre tract and passing at 478.02 feet a ¾ inch iron pipe found with cap marked "R.I. BAKER \$5539", to a steel nail found in the centerline of Iams Road;

Thence South 32°30'00" East 380.31 feet, following the centerline of Iams Road, the northeast line of V.M.S. 1479, the southwest line of V.M.S. 3460, and the northeast line of said original 50.000 acre tract, to the place of beginning, containing 4.359 acres, more or less, and being subject to all valid easements and restrictions of record.

Bearings indicated herein are based on South 32°30'00" East for the centerline of Iams Road with all others based on angles turned.
