

## 58.1840 Acre Tract Surveyed for Hughes and Johnson

The following described 58.1840 acre tract is situated in the State of Ohio, Madison County, Stokes and Paint Townships, VMS 3983, being part of the original 215 acre tract (202.7196 acres to date) conveyed to Marilyn J. Hughes and Virginia L. Johnson by Official Record 242 page 459, and being more particularly described as follows:

Beginning at a 3/4 inch diameter electrical conduit found in the centerline of Foody Road (Township Road 87)(50 ft. right-of-way), said conduit is at the northeast corner of a 2.7547 acre tract conveyed to Joseph Sexton, Et al by Official Record 201 page 2222, also corner to said 202.7196 acre tract;

Thence, with the north line of said 2.7547 acre tract, North 85° 38 minutes 24 seconds West, passing a 5/8 inch diameter rebar and yellow plastic cap stamped "R. I. Baker 5539" (found) at 20.11 ft., a total distance of 500.00 ft. to a 5/8 inch diameter rebar and yellow plastic cap stamped "R. I. Baker 5539" (found) at the north east corner of a 2.5477 acre tract conveyed to Joseph Sexton, et al. by Official Record 201 page 2222;

Thence, with the north line of said 2.5477 acre tract, North 85° 38 minutes 24 seconds West a distance of 477.35 ft. to a 5/8 inch diameter rebar and yellow plastic cap stamped "R. I. Baker 5539" (found) in the east line of a 944.3474 acre tract conveyed to Indian Run Aglands, et al. by Official Record 245 page 2530;

Thence, with said 944.3474 acre tract the following 2 courses:

- 1) North 03° 19 minutes 22 seconds West a distance of 1910.23 ft. to an iron pin and cap set
- North 11° 19 minutes 14 seconds West a distance of 375.75 ft. to a double angle iron fence post found at the southwest corner of a 117.84 acre tract conveyed to Mary A. Emrich, Trustee by Official Record 106 page 1952;

Thence, with the south line of said 117.84 acre tract, South 86° 44 minutes 57 seconds East a distance of 673.84 ft. to the southwest corner of a 5.1311 acre tract conveyed to Chris C. Emrich by Official Record 78 page 963 (a 3/4 inch diameter electrical conduit found is 0.23 ft. north);

Thence, with the south line of said 5.1311 acre tract, South 86° 44 minutes 57 seconds East a distance of 349.62 ft. to the northwest corner of a 2.978 acre tract conveyed to Marilyn J. and David J. Hughes by Deed Book 287 page 436;

Thence, with said 2.978 acre tract the following 2 courses:

- 1) South 06° 45 minutes 45 seconds West, passing a 3/4 inch diameter electrical conduit found at 0.10 ft., a total distance of 330.00 ft. to an iron pin and cap set (buried 1 ft. deed);
- South 86° 46 minutes 33 seconds East, passing an iron pin and cap set at 373.37 ft., a total distance of 396.71 ft. to a mine spike found in the centerline of said Foody Road;

Thence, across said original 215 acre tract the following 5 courses:

- 2) South 39° 27 minutes 56 seconds West a distance of 416.74 ft.
- 3) South 71° 13 minutes 18 seconds West a distance of 143.36 feet
- 4) North 63° 52 minutes 31 seconds West a distance of 472.11 ft.
- 5) North 55° 10 minutes 55 seconds West a distance of 85.56 ft. to a point in the west line of the said original 215 acre tract and the western terminus of said 40 ft. drainage easement.

Beginning at a mine spike found in the centerline of Foody Road (Township Road 87)(50 ft. right-of-way), said buying spike is at the north west corner of a 100 acre tract conveyed to Marion L. Vallery, et al. by Official Record 64 page 127, also corner to said 202.7196 acre tract;

Thence, with the Centerline of said Foody Road and a new line across said 215 Original acre tract, North 06° 36 minutes 08 seconds East a distance of 1764.55 ft. to a mine spike found at the southwest corner of a 4.000 acre tract conveyed to Virginia L. Johnson, Et Al. by Official Record 37 page 311;

Thence, with said 4.000 acre tract the following 2 courses:
