Commencing at a mag nail found in the centerline of Pringle Benjamin Road (County Road 65)(right-of-way width unknown) said mag nail is at the northwest corner of said 20.684 acre tract and the northeast corner of a 3.50024 acre tract conveyed to Mark D. and Alicia L. Tremayne by Official Record 155 page 2302;

Thence, with the centerline of said Pringle-Benjamin Road, South 88° 15 minutes 00 seconds East a distance of 270.00 ft. to a mag nail set at **The True Point of Beginning**;

Thence, continuing with the centerline of said Pringle-Benjamin Road, South 88° 15 minutes 00 seconds East a distance of 204.37 ft. to a mag nail set;

Beginning at a mag nail found in the centerline of Pringle Benjamin Road (County Road 65)(right-of-way width unknown) said mag nail is at the northwest corner of said 20.684 acre tract and the northeast corner of a 3.50024 acre tract conveyed to Mark D. and Alicia L. Tremayne by Official Record 155 page 2302;

Thence, with the centerline of said Pringle-Benjamin Road, South 88° 15 minutes 00 seconds East a distance of 270.00 ft. to a mag nail set;

Thence, across said 20.684 acre tract the following 4 new courses:

- 1) South 01° 29 minutes 28 seconds West, passing an iron pin and cap set at 32.47 ft., a total distance of 355.73 ft. to an iron pin and cap set
- 2) South 00° 45 minutes 20 seconds West a distance of 103.77 ft. to an iron pin and cap set
- 3) South 86° 01 minutes 35 seconds East a distance of 222.72 ft. to an iron pin and cap set
- 4) South 00° 53 minutes 27 seconds East a distance of 541.28 ft. to an iron pin and cap set in the north line of a 62.25 acre tract conveyed to Ronald G. and Donna J. Guyton

Beginning at a mag nail set over an iron pin found in the centerline of Pringle Benjamin Road (County Road 65)(right-of-way width unknown) said mag nail is at the northeast corner of said 20.684 acre tract and the northwest corner of Wrightsville Estates as shown on slide # 466;

Thence, with the west line of said that Wrightsville Estates, South 09° 31 minutes 00 seconds East, passing an iron pin and cap set at 21.76 ft., also passing the northwest corner of Lot 1 of said Wrightsville Estates conveyed to Carol L. Young by Official Record 200 page 2152 at 30.60 ft., a total distance of 670.25 ft. to a ½" diameter iron pipe found at the southwest corner of said Lot 1, also being corner to a 62.25 acre tract conveyed to Ronald G. and Donna J. Guyton by Deed Book 281 page 221;

Thence, with said 62.25 acre tract the following 2 courses:
