

## SURVEY FOR TOM JOHNSON 0.448 Acre November 12, 2009

The following described 0.448 acre tract is situated in the State of Ohio, County of Madison, Village of Plain City, and V.M.S. 7064, being part of Tom Johnson's Lot 9 (Tract I), all of Lot 7 and Lot 8, and part of Lot 6, all described in Official Record 112, page 2094, also including all of a 16 feet wide vacated alley between Lot 6 and Lot 7 and the north part of a 16.5 feet wide vacated alley between Lot 6 and Lot 9, said vacated alleys described in Official Record 252, page 1394, all Lots and alleys are part of A.H. Sherwood's Second Addition recorded in Plat Book 1, Page 169, and said 0.448 acre tract being more particularly described as follows:

Beginning for reference at a ¾ inch iron pipe found with cap marked "JAM PS 5963" at the intersection of the north line of South Avenue (35 feet wide) with the west line of Dry Street (35 feet wide), said iron pipe being at the southeast corner of Lot 4 of said Addition;

Thence North 20°46'03" West (assumed bearing) 120.14 feet, following the west line of Dry Street and the east line of Lot 4, Lot 5, and Lot 6 of said Addition, to an iron pin set and marking the place of beginning;

Thence South 69°17'00" West 158.81 feet, departing from the west line of Dry Street, crossing said Lot 6, a vacated 16 feet wide alley and Lot 9, to a 5/8 inch iron pin set in an east line of Plain City Senior Center's 10.259 acre tract described in Deed Record 250, page 583;

Thence North 01°55'24" East 190.71 feet, following the west line of said Lot 9, the west end of a 16 feet wide alley, the west line of Lot 7, the west line of Lot 8, and an east line of said 10.259 acre tract, to a 3/4 inch iron pipe found at the northwest corner of said Lot 8;

The following described 0.507 acre tract is situated in the State of Ohio, County of Madison, Village of Plain City, and V.M.S. 7064, being part of Tom Johnson's Lot 9 (Tract I), all of Lot 4 and Lot 5 (Tract II), and part of Lot 6, all described in Official Record 112, page 2094, and including part of a 16 feet wide vacated alley between Lots 4, 5, 6 and Lot 9, said vacated alley described in Official Record 252, page 1395, all Lots and alleys are part of A.H. Sherwood's Second Addition recorded in Plat Book 1, Page 169, and said 0.507 acre tract being more particularly described as follows:

Beginning at a ¾ inch iron pipe found with cap marked "JAM PS 5963" at the intersection of the north line of South Avenue (35 feet wide) with the west line of Dry Street (35 feet wide), said iron pipe being at the southeast corner of said Lot 4, said iron pipe marking the place of beginning;
