

0.0590 Acre Tract Surveyed for Paul Fornof

The following described 0.0590 acre tract is situated in the State of Ohio, Madison County, Monroe Township, VMS 12070, the purpose of this survey is to resolve a deed overlap between a 360.9819 acre tract conveyed to Betty J. Bethel and Paul E. Fornof (also see Deed Book 207 page 366 a 153.27 acre tract) and a 1.2856 acre tract conveyed to Rodney B. and Barbara J. Ayres by Official Record 40 page 355, and being more particularly described as follows:

Commencing at an iron pin found in the centerline of Thomas Road (Township Road 121)(right-of-way width unknown) said iron pin is at the southernmost corner of a 45.72 acre tract conveyed to Robert Lee Persinger by Deed Book 279 page 231, said iron pin bears North 18° 53 minutes 42 seconds East a distance of 15.20 ft. from a PK nail found at the centerline intersection of said Thomas Road with Becker Road (County Road 120)(50 ft. right-of-way);

Thence, with the southwest line of said 45.72 acre tract being 15 ft. north east of the centerline of said Becker Road, North 61° 46 minutes 01 seconds West a distance of 332.09 ft. to a point in the southeast line of said 1.2856 acre and at **The True Point Beginning**;

Commencing at a centerline monument box found at the intersection of State Route 29 (60 ft. right-of-way) with the centerline of Thomas Road (Township Road 121)(right-of-way width unknown) said monument is at the southernmost corner of a 1.01 acre tract conveyed to Ralph L. Ward, Et al by Deed Book 265 page 276;

Thence, with the centerline of said State Route 29, North 53° 16 minutes 31 seconds West, passing an iron pin found at the southernmost corner of a 153.27 acre tract conveyed to Fornof by Deed Book 207 page 366 at 22.16 ft., a total distance of 200.00 ft. to a mag nail set in said centerline at the westernmost corner of said 1.01 acre tract and at **The True Point Beginning**;
