

DESCRIPTION OF 0.381 ACRES LOT NUMBERS 3 AND 4 GOULD & WELDON'S SUBDIVISION CITY OF LONDON MADISON COUNTY, OHIO

Situate in the City of London, County of Madison, State of Ohio and being all of Lot Numbers 3 and 4 of Gould and Weldon's Subdivision as conveyed to Geo-Sites, Ltd. In Official Record 231, Page 1081 and Official Record 221, Page 1157, more particularly described as follows: (all references to deed books, official records, microfiche numbers, instrument numbers, survey records and/or plats refer to the Madison County Recorder's Office, Madison County, Ohio)

Beginning at a 5/8" iron pin set on the southwest right-of-way line of Oak Street at the northernmost corner of said Lot 3;

Thence along the southwest right-of-way line of Oak Street, South 44°55'56" East a distance of 126.87 feet to a 5/8" iron pin set on the northwest line of a 16.5 foot wide alley at the easternmost corner of said Lot 4:

Thence along the northwest line of said alley, **South 45°00'00" West** a distance of **130.64** feet to a 5/8" iron pin se on the northeast line of a 16.5 foot wide alley at the southernmost corner of said Lot 4;

Thence along the northeast line of said alley, North 45°00'00" West a distance of 126.87 feet to a 5/8" iron pin set on the southeast line of a 16 foot wide alley at the westernmost corner of said Lot 3;

Thence along the southeast line of said alley, North 45°00'00" East a distance of 130.79 feet to the place of beginning.
