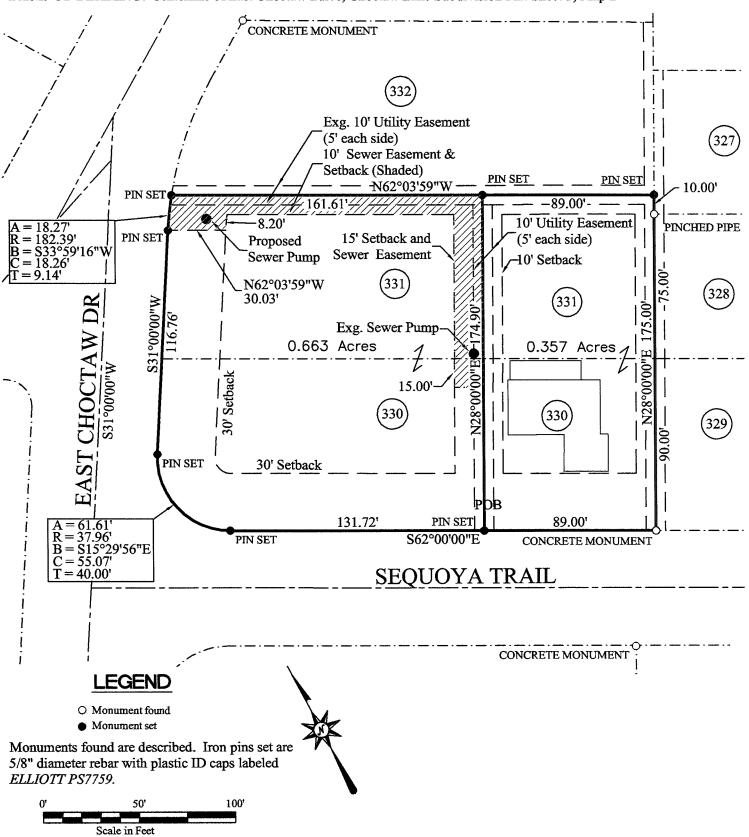

## DESCRIPTION OF A 0.357 ACRE RE-PLAT OF LOTS 330 AND 331

#### CHOCTAW LAKE SUBDIVISION

in Virginia Military Survey 3900 Somerford Township, Madison County, Ohio

This description is for a 0.357 acre tract consisting of parts of Lot 330 and Lot 331, Choctaw Lake Subdivision (Cabinet B, Sheet 19, 20, and 23, Madison County Recorder) in the name of Robert C. and Harriet W. Dana (Official Records 258, 1280, Madison County Recorder), located on the northeast corner of Sequoya Trail and East Choctaw Drive in Virginia Military Survey 3900, Somerford Township, Madison County, Ohio and is further described as follows:

Commencing at a concrete monument found on the northeast Right-of-way of Sequoya Trail, said monument marks the common southern corner of Lot 330 and Lot 329 as shown on the said plat of Choctaw Lake, then N62°00'00"W, 89.00 feet, along the northeast Right-of-way of Sequoya Trail, to an iron pin set at the **TRUE POINT OF BEGINNING** of this description;
