

0.2688 Acre Tract Surveyed for Canaan Township Trustees

The following described 0.2688 acre tract is situated in the State of Ohio, Madison County, Canaan Township, VMS 6648, being part of a 12.0549 acre tract conveyed to Earl Osborne and Rebecca O. Raber by Official Record 262 page 2029, and being more particularly described as follows:

Commencing at a point in the centerline of the old Plain City-Georgesville Road (County Road 7) (right-of-way width varies), said point is at the southwest corner of a 1.4 acre tract conveyed to the Baptist Church Parsonage by Deed Book 46 page 509;

Thence, with the south line of said 1.4 acre tract, South 82° 17 minutes 30 seconds East, passing an iron pin and cap set at 50.69 ft., also passing a 3 in. diameter metal fence post found at the southwest corner of a 0.7690 acre tract conveyed to Canaan Township Trustees by Deed Book 263 page 375 at 179.64 ft., also passing an iron pin and cap set at 190.38 ft., a total distance of 644.72 ft. to the southeast corner of said 0.7690 acre tract and in the west line said 12.0549 acre tract;

Thence, with the east line of said 0.7690 acre tract, North 07° 37 minutes 08 seconds East a distance of 72.83 ft. to a 4 in. diameter metal fence post found corner to a 17.955 acre tract conveyed to Earl Osborne and Rebecca O. Raber by Official Record 262 page 2029 and **The True Point Beginning**;

Thence, with the south line of said 17.955 acre tract, North 85° 57 minutes 13 seconds East a distance of 30.68 ft. to an iron pin and cap set;

Thence, across said 12.0549 acre tract the following 2 new courses:

- 1) South 07° 37 minutes 30 seconds West a distance of 393.08 ft. to an iron pin and cap set
- 2) North 82° 21 minutes 49 seconds West, passing an iron pin and cap set at 27.00 ft., a total distance of 30.00 ft. to a 4 inch square vinyl fence post found at the southeast corner of the grounds occupied by the Canaan Township Trustees Cemetery;

Thence, with the east line of said cemetery, North 07° 37 minutes 08 seconds East a distance of 314.04 ft. to the southeast corner of said 0.7690 acre tract;

Thence, with the east line of said 0.7690 acre tract North 07° 37 minutes 08 seconds East a distance of 72.83 ft. returning to **The True Point Beginning** containing **0.2688 Acres** more or less.

The following described 3.6134 acre tract is situated in the State of Ohio, Madison County, Canaan Township, VMS 6648, 12071-12881, being part of a17.955 acre tract conveyed to Earl Osborne and Rebecca O. Raber by Official Record 262 page 2029, and being more particularly described as follows:

Beginning at a mag nail found in the centerline of Plain City-Georgesville Road (County Road 7) (right-of-way width varies), said mag nail is at the northwest corner of a 1.4 acre tract conveyed to the Baptist Church Parsonage by Deed Book 46 page 509, said mag nail is also corner to said 17.955 acre tract;

Thence, with the centerline of said Plain City-Georgesville Road, North 20° 04 minutes 24 seconds East, passing a centerline monument found at Station 237+00 at 10.19 ft., a total distance of 30.00 ft. to a mag nail set in said centerline;

Thence, across said 17.955 acre tract the following 2 new courses:

- 1) South 82° 20 minutes 50 seconds East, passing an iron pin and cap set at 29.69 ft., a total distance of 600.13 ft. to an iron pin and cap set
- 2) South 07° 37 minutes 30 seconds West a distance of 313.93 ft. to an iron pin and cap set in the north line of a 12.0549 acre tract conveyed to Earl Osborne and Rebecca O. Raber by Official Record 262 page 2029;

Thence, with the north line of said 12.0549 acre tract, South 85° 57 minutes 13 seconds West a distance of 30.68 ft. to a 4 in. diameter metal fence post found at the north east corner of a 0.7690 acre tract conveyed to Canaan Township Trustees by Deed Book 263 page 375;

Thence, with the north line of said 0.7690 acre tract, North 82° 20 minutes 46 seconds West a distance of 457.02 ft. to a 3/4 inch diameter iron pipe and aluminum cap stamped "N. C. B. 5969" found in the east line of said 1.4 acre tract;

Thence, with said 1.4 acre tract the following 2 courses:

- 1) North 13° 58 minutes 11 seconds East a distance of 254.77 ft. to a 10 in. diameter wood post found
- 2) North 68° 03 minutes 30 seconds West, passing a 5/8 inch diameter rebar and yellow plastic cap stamped "Clapsaddle RS6140" found at 3.00 ft., also passing a 3/4 inch diameter iron pipe and aluminum cap stamped "N. C. B. 5969" found at 116.64 ft., a total distance of 152.42 ft. returning to the point beginning containing **3.6134 Acres** more or less.
